Good Day! by Maureen Rupe Rezoning at Ranch Road/Grissom Blvd - This rezoning is for two 120-foot by 84-foot storage buildings (10,080SF). The lot line of the storage buildings is approximately 320 feet from Grissom Blvd. with a stormwater pond just in front of the storage building, about 80 feet from Grissom Blvd. The storage building is on the southern-most lot next to Ranch Road. The zoning request will not be heard by the Port St. John Special District Planning & Zoning Board as it's not within the boundaries of the Port St. John Special District. It is under the Brevard County Planning & Zoning Board only, before the revision goes before the Brevard County Commission. The item is tabled to the March 25th meeting as it is being revised.

M&R United, Inc. (Carmine Ferraro) requests a change of zoning classification from BU-1 (General Retail Commercial) to BU-2 (Retail, Warehousing and Wholesale Commercial). The property is 13.27 acres, located on the west side of Grissom Parkway between Cinnamon Fern Blvd. and Ranch Road (no assigned address).

Planning and Zoning Board Recommendation: Lawandales/McLellan - Tabled to the March 25, 2019, Local Planning Agency meeting. The vote was unanimous.

Bio-Solids, the 900lb. Gorilla next to the La-

I've been talking about Bio-solids in Happenings since at least 2012. You can find a letter on the Facebook page of the Brevard Indian River Coalition where I wrote to the Brevard County Commission in November, 2017 about Florida Bio-solids:

"... there are 83 sites the Department of Environmental Protection allows landowners to dump "Class B" waste. Class B is more regulated due to fecal and heavy metal content it contains after treatment. The article shows a map of the active sites allowing Class B effluent, two are

in Brevard county, both within a couple miles of the Indian River Lagoon. Site FLA395731 (Jakubcin) is 200 acres (4890 Lloyd St., Mims), less than 4 miles from the Indian River Lagoon, and has 176.7 dry tons applied (353,400 pounds). Site FLA844462 (Port St. John Site) is 85.5 acres (Ranch Road, Port St. John), less than 2 miles from the Indian River Lagoon, and has 16.335 dry tons applied (232,670 pounds)."

Brevard has two Class B Human Waste dump sites. One 200-acre site at 4890 Lloyd Street, Mims, and one 85.5-acre site on Ranch Road in Port St. John.

Biosolids is just a more acceptable way of saying "human feces," the solids left when you have a bowel movement on the toilet. This "Human Body Waste" is being sold to the public as a good thing to use for agriculture because it does contain nitrogen and phosphorus. But just like everything else, too much of anything, if it is not needed, can be detrimental. The Biosolid Regional Summit in Fort Pierce, Florida on June 8, 2018, gave, among other things, the following facts:

Fact 2: it is documented by the US Environ-

mental Protection Agency (EPA) that in Florida, 53% of its rivers, 82% of its lakes and reservoirs and 32% of bays and estuaries are impaired by nutrients, specifically total phosphorous (TP) and total nitrogen (TN).

Fact 6: A substantial amount of imported nutrients within watersheds become discharged into surface waters. As an example, it has been estimated in Lake Okeechobee contributing basins that over 11% of the total TP import and over 13% of TN import are annually eroded and discharged into surface waters.

Fact 9: Both AA and Class B biosolid products contain an average concentration of nutrients that varies around 5.5 percent nitrogen and 2.2 percent phosphorus.

Fact 15: if you assume 11% of 1,000 tons of TP from Class AA biosolids within that Lake Okeechobee watersheds are discharged to surface waters which is equal to 110 tons of TP to surface waters annually (equivalent to 220,000 lbs.). Then it would equivalently add a cost of \$26,400,000 annually to remove the TP from the surface waters assuming \$120 per pound removal rate employing shallow water STAs.

since 2013. Class AA human waste, otherwise known as "biosolids," can be spread anywhere same as regular fertilizer. The Titusville waste treatment plant known as "Osprey" has been reporting in 2014 through 2017 that it was putting out around 230 tons of human waste at the Mims and Port St. John dump sites.

There are 13 waste plants listed in Brevard on the Florida's listing of Waste Treatment plants, including: Mims, Titusville Osprey, Port St. John, Skyes Creek, Rockledge, David B. Lee Water Reclamation and Palm Bay. Whatever the human waste is cleaned to, it still has the same nitrogen and phosphorus concentrations (Fact 9), so it should be an easy assumption that the other sites in Brevard produce at least 1,000 tons per year. It is easy to show we are spending the same as the Okeechobee watershed, so we are essentially wasting \$26,400,000 per year. Aren't we putting the nitrogen back into the Indian River Lagoon, while at the same time spending our taxes of more than \$26,400,000 per year to pull out muck and fix sewage pipes

Only Class B human waste has been tracked to keep nitrogen and phosphorus out of the Indian River Lagoon?

What other problems are there? I found a Noor sold outside of the state as it's considered the vember 15, 2018 EPA Report, No. 19-P-0002, titled "Unable to Assess the Impact of Hundreds of Unregulated Pollutants in Land-Applied Biosolids on Human Health and the Environment." The 66-page report was written by EPA's Inspector General and I can't list everything, but on page 14-15, it states two concerning paragraphs:

> "Existing biosolids data and studies do not fully examine the pollutants found in biosolids, especially unregulated pollutants. Until such research and data exist, the EPA cannot determine if any regulations should be issued. In over 20 years, no new pollutants have been regulated."

> "Piecing together information from the 2015 biennial biosolids review, the 2001 and 1989 National Sewage Sludge Surveys and other information, the EPA identified 352 pollutants in biosolids. The EPA does not have complete risk assessment information on these pollutants; therefore the agency cannot say whether

the pollutants are safe or unsafe when found in biosolids."

Still on page 15: "We took the EPA's list of 352 pollutants without full risk assessment data and compared that list with three other hazardous lists: (a) the Resource Conservation and Recovery Act (RCRA) hazardous waste listings, (b) the EPA priority pollutant list, and (c) the National Institute for Occupational Safety and Health's (NIOSH's) list of hazardous drugs. We found that 61 of the 352 pollutants appeared on one or more of the hazardous lists. According to the EPA, without risk assessments on each chemical, it is unknown whether the pollutants in biosolids are harmful. Of the 352 biosolids pollutants:

- 32 are hazardous wastes under RCRA (four of which are acutely hazardous).
 - 35 are EPA priority pollutants.
 - 16 are NIOSH hazardous drugs"

Residents of Port St. John and Canaveral Groves needs to remember the Port St. John dump site is just north of Space Coast Middle School, and well within smell distance. What about our yards? Both the Port St. John and Mims dump sites are on Bahia grass according to dump site records. Are they selling the Bahia grass? Are all these pollutants and 61 hazardous pollutants in all our Brevard neighborhoods? Is it being sold outside of our county across all of central Florida? But we have to get rid of the human waste, don't we?

With all the fish kills and algae blooms, the state is starting to wise up, and in 2018 created the DEP Biosolid Technical Advisory Committee (BTAC). I've given the link below to their webpage. I have a friend who attended 4 of the 5 days they met starting in September, 2018, 3 days in November, 2018, and their last day on January 23, where they disbanded. My friend was not impressed with what was decided, as in his words, "Too many people involved with the BTAC are invested in the current scheme and its infrastructure."

Brevard County is passing the buck by saying it's the state's responsibility. They seem to be so determined to update the sewer systems and connect at least all homes within a few hundred feet of the Indian River Lagoon to those sewer

systems, they are forgetting the 900 lb. gorilla watching from the shores. We are spreading reclaimed water (with nitrogen and phosphorus) around the county and spreading at least Class A or AA biosolids around the county, either directly on agriculture land or even sold as fertilizer. I'm told the Class B biosolids are taken to the county landfill, but no one seems to know as they haven't tracked the spreading of AA biosolids since 2013. Shouldn't the county at least be challenging the state on Bio-solids? Aren't Brevard residents' health being affected by this?

Federal Court Rules in Favor of Parrish Medical Center

A federal judge has ruled in favor of Parrish Medical Center (PMC) and against seven oncologists who sought an injunction to restore their privileges to practice at the Titusville hospital. The seven physicians—Germaine Blaine, Cynthia Bryant, Juan Castro, Ashish Dalal, Firas Muwalla, Brendan Prendergast and Richard Sprawls, had sought a preliminary injunction against PMC, claiming their due process rights had been denied and that PMC's bylaws were breached.

The court found that neither situation had occurred and denied the physicians' request. The ruling was issued Feb. 4, 2019, by U.S. District Judge Roy B. Dalton, Jr. The dispute centered on the physicians' refusal to provide patient care data to PMC. Having received what the court said was a "full panoply of due process protections," the seven physicians' privileges were not renewed by PMC due to the physicians' consistent failure to provide PMC with essential patient care data.

The court noted that "...PMC found that the Plaintiffs' failure to comply with PMC's request for patient data hindered the cancer program." This failure constituted "relevant considerations" for PMC.

The Court's Order cited that "... at this stage, the Court finds no fault in this course of action—rather, the Bylaws contemplate denial of reappointment on such grounds so long as the reappointment process is followed." The court also noted that, "Each reviewing body at PMC found that Plaintiffs' failure to comply with PMC's request for patient data hindered the cancer program and the delivery of quality of patient care and could cause the loss of accreditation in the future," the court said.

"The court's decision validated the actions taken to not renew the physicians' privileges," said Joseph Zumpano of Zumpano Patricios. "The court found that PMC's Board of Directors and administration did the right things, the right way, according to policies, bylaws, and the law."

PMC has Brevard County's longest continually accredited program by the American College of Surgeons Commission on Cancer (CoC). First accredited in 1989, PMC is one of only two CoCrecognized programs in Brevard County.

Monthly Tax Update

This month let's talk about non-traditional income sources the Internal Revenue Service is targeting. This includes income from Lyft, Uber, or delivery drivers, home rentals through Airbnb or VRBO, GoFundMe or Kickstarter and virtual currency such as Bitcoin. First, let's discuss independent driver arrangements including Lyft, Uber, delivery services or other vehicle support activities. These arrangements are viewed as independent contractors receiving compensation and considered self-employment. You are responsible to pay for your own Federal withholding taxes and the self-employment taxes (Social Security and Medicare taxes) on the net profit earned from your vehicle services being provided. You will file the Schedule C for Form 1040 to report your gross income and all your expenses to arrive at your net profit. Expenses include vehicle (either mileage or actual), cell phone, extra vehicle insurance, fees and commissions paid, parking and tolls, credit card processing fees, anything provided to the customers and any other associated fees. Don't most popularly known at Bitcoin. The income forget, you have to maintain a mileage log to substantiate your business miles.

Next, you decide to rent your house or a room. This type of activity has special circumstances. If you rent out your home or room for short-term rentals (less than 14 days per year), the income is not taxable regardless of how much you earn. However, if you rent out your home or room for more than 14 days, then you are subject to tax on the income that exceeds your direct expenses and only a portion of the general or shared expenses based on days of rental versus personal use. You'll complete Schedule E for Form 1040 to report this activity or it could be classified as a business activity due to the amount of rental activity and require you to file the Schedule C for Form 1040.

Kickstarter are determined on a case-by-case basis. Believe it or not, GoFundMe funds are treated as a gift and not taxable to the recipient and no deduction is allowed from the funding source. Whereas, Kickstarter campaigns are taxable income, unless specifically identified as a loan or a capital contribution to an entity in exchange for an equity interest.

My final topic deals with Virtual Currency, from this is treated as ordinary income or a capital asset and depends on the facts and circumstances. It is important to accurately record your virtual currency transactions. Some transactions

are for the payment of services, which is income. Then, you spend the currency for something and the characteristics of the currency results in capital gain or loss on the liquidation of the currency and at the same time results in a possible deduction if used for business needs. Therefore, for tax purposes, you need to track how and when you received the currency, the value on the date you received the currency, the date the currency was traded or used, the value on the date of the trade or use, and what you did with the currency when you traded or used it.

Parrish Medical Center Recycles to Aid the Homeless in North Brevard

Blue medical wraps used in Parrish Medical Center's operating rooms to cover and safeguard sterilized surgical instruments will find a second use in covering and safeguarding the homeless.

The water-resistant, heat-sustaining wraps shield surgical instruments after they are sterilized for operating room use. The wraps are removed and discarded prior to starting the procedure.

Sherry Pierce, CRNA, learned of a recycling project online from a medical center in Camden, New Jersey and brought the idea to Rebecca Tipton, manager of Perioperative Services. They realized there could be a better use for the excess medical equipment at Parrish Medical Center, too.

"I had seen the medical wraps could be converted for use by the homeless," Pierce said. "I thought about our hospital's vision, 'Healing Families— Healing Communities.®' It's another

A team of operating room care partners have volunteered to assemble and sew the wraps into mats, sleeping bags, pillows and drawstring travel bags. There's no set goal on quantities, but Tipton says, "The more the better." When the wraps are completed they will be donated to North Brevard

Charities Sharing Center for their use in aiding the homeless.

"When Sherry presented the idea, the surgical team was immediately enthusiastic about it," said Matt Graybill, director of Perioperative Services.

More than 30 million Americans are living with diabetes. At least 1 in 3 will develop diabetes in his or her lifetime. Fortunately, there are ways to avoid common problems and live well with the disease.

What is diabetes?

Diabetes is a lifelong condition that results when the body is not able to use food properly for energy. Diabetes increases your risk for heart disease and stroke. It is a serious medical condition, but you can learn to manage it and avoid complications by taking care of yourself.

What factors increase my risk?

You can't change a family history of diabetes, your age (being older than

45) or your ethnic background. People with African-American, Alaska Native, American Indian, Hispanic, Asian and Pacific Islander genes are at higher risk.

But you can control being overweight, being sedentary, having high blood pressure, having high blood cholesterol and developing prediabetes or gestational diabetes.

If I have diabetes, how can I live well?

First, learn all you can about the disease and get support. Know your diabetes ABCs: A is for the A1C test, which measures your average blood glucose over time; B is for blood pressure; and C is for cholesterol. Talk to your healthcare team about how to manage these.

Know how to monitor your blood glucose. Bring your monitor and log book to all medical appointments.

Take any medications as prescribed and talk to your doctor if you have side effects or your blood glucose is consistently too high or low.

Make smart food choices and lose weight, if needed. Be consistent about eating three to five small meals or snacks a day. Reduce fat. Choose healthy carbohydrates, like whole-grain breads. Eat fresh fruits, veggies and beans.

Drink plenty of water.

Exercise and be active. Start where you are and aim for 30 minutes of exercise or activity on most days.

Quit smoking.

Stay motivated. Make use of diabetes education and nutrition services.

Though managing your diabetes isn't always easy, living well is possible—and you're always worth it.

Lung cancer is the nation's leading cancer killer – taking the lives of more people each year than breast, colon and prostate cancers combined.

Anyone with a history of smoking is encouraged to talk with their doctor to see if a lung cancer screening is right for them.

Last Naval Battle of the **Revolutionary War Ceremony**

On March 9th, starting at 10 a.m., the Sons, Daughters and Children of the American Revolution will be hosting a ceremony to commemorate the 236th Anniversary of the last Naval battle of the Revolutionary War. The event is open to all who want to attend. It will be held at the Brevard Veterans Memorial Museum & Military Museum, 400 S Sykes Creek Pkwy., (behind Merritt Square Mall on Merritt Island,) on the Veteran's Center and Museum grounds.

According to a state historic marker: "The last naval battle of the American Revolutionary War took place off the coast of Cape Canaveral on March 10, 1783. The fight began when three British ships sighted two Continental Navy ships, the Alliance commanded by Captain John Barry, and the Duc De Lauzun commanded by Captain Florida."

The 1938 biographical narrative of Captain John Barry's places the British ships "some 30 leagues southeast of Cape Canaveral." In 1938, there wasn't much of interest on Florida's east coast, so we might still have been the nearest established town. Nonetheless, the last naval battle of the American Revolution is still a part of Florida history.

This year the Coast Guard Auxiliary is providing support to include a band, singer, taps and a ship that will be anchored behind the Veterans Center. Color guards will get credit for participation in a nationally sponsored SAR event.
