Parrish Healthcare Ready For COVID-19 Surge

Parrish Healthcare care partners were swift to mobilize our COVID-19 response dedicating all necessary resources to assure the health and safety of the community we serve, our fellow care partners and patients. We know from experience that North Brevard is usually last on the list to receive any sort of assistance from officials. That is why we prepared early and acted swiftly to mobilize our COVID-19 response.

- Our swift actions helped assure our care partners have the personal protective equipment needed to care for COVID-19 patients and we continue to aggressively procure additional supplies.

- We set up a 40x60 foot Alternate Care Site that is fully equipped to serve as an overflow medical treatment site if and when needed.

- We were the first in Florida to offer an on-line COVID-19 risk assessment and free clinical consultations.

- Our facilities team converted an entire hospital wing into a negative pressure unit to care for COVID-19 patients while keeping our care partners protected. Additionally, the entire in-

tensive care unit (ICU) has been converted to serve as a dedicated COVID-19 unit for the critically ill.

- We are connecting patients with loved ones through virtual visitation. COVID-19 response made it necessary for us to restrict hospital visitations. We understand the emotional impact this has on families, and the affect this can have on a person's ability to heal. We are connecting hospitalized patients with their loved ones through video visits.

- We are screening everyone daily, including providing face masks and daily temperature checks, before entering any of our facilities to assure safe and healing environments.

- Our COVID-19 Call Center was activated in early March as a service to the community to help answer questions and alleviate fears.

- Our physicians are offering telehealth visits to allow patients to get the care they need without needing to leave their homes.

- To prevent infection risk, we set up a free day care center for our fellow care partners who are on the frontlines of the COVID-19 response

at no cost to them. We remain staffed and ready.

- Also to reduce contamination risk, we offer convenient grocery pick up to care partners inside our Atrium Café. Grocery staples are offered to care partners at cost here to prevent any possible contamination from going to community stores.

- Our Nathaniel Pilate Hardship Fund provides emergency assistance to our care partners and their families who may be struggling during this difficult time.

1,000 Gallons of Hand Sanitizer Donated to Brevard County First Responders

Pharmco Laboratories Inc., a skin care product manufacturer based in Titusville, donated seven pallets of half-gallon bottles of hand-sanitizer to Brevard County's first responders in June, adding to the county's arsenal of Personal Protection

Equipment in the response to COVID-19.

In all, 1,000 gallons of hand sanitizer was donated by the company, which has been in operation since 1979. The company specializes in skin care formulas and over-the-counter skin care products. The donation was made by Pharmco President Robert Cohn, Director of Operations, Ben Cohn and Director of Sales Darren Curtis to Brevard County Commission Chair Bryan A. Lober, Public Safety Director Matt Wallace and Fire Rescue Chief Mark Schollmeyer at a warehouse facility located on Technology Drive in Melbourne.

Wallace said the county's first responders burn through supplies pretty quickly in their response efforts during the pandemic.

There are 33 fire stations, and three shifts per day, and, "Every time you go on a call, you're wiping your hands down," so the county goes through supplies pretty quickly, Schollmeyer said.

"We had been talking about it, 'How can we give back to the community and help those around us,'" Curtis said about Wednesday's donation.

Face Masks with Filters

More than 20 states now require people to wear face coverings in public. As more states make wearing face coverings in public mandatory, many wonder if masks with filters are more effective.

"Any cloth mask is going to protect others from whatever secretions you might inadvertently have, says Dr. Marty, a professor of infectious diseases at Florida International University. "But if you add that filter, then you're also adding a really good protection for yourself."

Filters, which are essentially another layer that goes underneath a mask, can either be pre-sewn onto a mask or manually inserted via a pocket. The ideal cloth masks that you really want to have is one that has an inner layer, a filter layer and an outer layer.

Filters are going to give you increased protection from the mask, as well as additional protection for others. The wonderful thing about filters is that it isn't just about the size of the filter. It helps collect the COVID-19 virus and keeps it from going beyond that filter layer. Don't forget to clean or change the filter often.

"The Occupational Freedom and Opportunity Act"

On June 30th, Governor Ron DeSantis signed "The Occupational Freedom and Opportunity Act" (HB 1193), which eliminates barriers of entry to certain professions licensed by the Florida Department of Business and Professional Regulation (DPBR) by adding endorsement and reciprocity provisions, removing supplemental business licenses and corresponding license fees, reducing licensure education requirements and eliminating other licensure and registration requirements.

The impacts of "The Occupational Freedom and Opportunity Act" include the following:

Enhancing Endorsement & Reciprocity Options

- Requires the Department to enter into reciprocal licensing agreements with other states for several professions and get Floridians to work.

- Requires the Department to post on its website the existence of reciprocal license agreements or which jurisdictions have substantially similar licenses with license requirements and examination.

- Endorses all current and active out-of-state barber and cosmetologist licenses in Florida.

- Adds endorsement of building administrators, inspectors, and plans examiners, or the equivalent certification of another state or territory of the U.S.

- Adds a category of home inspector licensure by endorsement for applicants who maintain an insurance policy as required by this state and have held a license for at least 10 years in another state or territory.

- Removes examination requirements for landscape architects applying for endorsement, requiring only that they hold a license by an-

other state or U.S. territory.

- Provides licensure by endorsement for electrical and alarm system contractors who have been licensed in another state for at least 10 years.

- Allows licensure of veterinarians by endorsement if they successfully completed a state, regional, national or other exam that is equivalent to, or more stringent than the examination required by the board.

Removing Duplicative Business Licences And License Fees

- Eliminates separate business licenses for architects, geologists and landscape architects who already hold an individual license in order to remove unnecessary barriers to entry.

- Allows yacht and ship brokers to maintain one license tied to their principal place of business without requiring additional licenses for each branch office.

Reducing Licensure Education Requirements

- Reduces pre-licensure and continuing education hours in order to alleviate the cost barrier to certain professions.

- Removes the continuing professional education requirement for applicants applying for licensure by endorsement as a certified public accountant.

- Reduces the number of training hours required to be eligible for barber licensure from 1200 to 900 and specifies that the 900 training hours must be in sanitation, safety, and laws and rules. Reduces program certification requirements from 1,000 to 600 hours.

- Reduces amount of hours needed for licensure for specialists. Nail specialists reduced

from 240-180 hours, facial specialists reduced from 260-220 hours, full specialists reduced from 500-400 hours.

- Lowers the continuing education requirement for cosmetologists from 16 hours to 10.

- Reduces the required continuing education hours for renewal of an alarm system contractor license from 14 hours to 7 hours every 2 years, and 14 to 11 hours for electrical contractors.

Eliminating Other Licensure And Registration Requirements

- Removes all provisions relating to the licensure of interior designers, although it allows for certification on an optional basis.

- Eliminates the registration and regulation of labor organizations by the Department.

- Removes registration requirements and licensure requirements for hair braiding, hair

wrapping and body wrapping by the Department.

- Eliminates the licensure requirement for timekeepers and announcers under the jurisdiction of the Florida State Boxing Commission.

Reforming Requirements In Other Regulated Professions

- Re-defines "one and two family dwelling inspector" as "residential inspector."

- Clarifies the limited types of veterinary medical services already permitted by rule, which include microchipping, vaccinations, immunizations and parasitic control.

- Includes completion of the (PAVE) Program for graduates of foreign schools of veterinary medicine that are not accredited by the American Veterinary Medical Association to qualify for licensure as a veterinarian.

- Allows cosmetologists or specialists performing services in connection with a special event to no longer be required to be employed by a licensed salon or be required to make an appointment for a special event through a licensed salon. Also properly licensed individuals may offer hair shampooing, hair cutting, hair arranging, nail polish removal, nail filing, nail buffing, and nail cleansing services outside of a licensed salon.

- Raises the dollar amounts of the construction licensing exemption for handyman jobs to \$2,500.

- Reduces the number of members on the Florida Building Commission from 27 to 19 members.

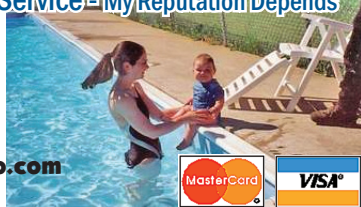

Brevard County Fire Rescue Offers Hurricane Tips

Brevard County Fire Rescue reminds residents that hurricane season has officially started in June. Hurricane season runs from June 1 through November 30. BCFR offers the following safety tips to ensure that your family is prepared before a hurricane strikes, during the storm and in the aftermath of the event.

Before a storm:

Understand how hurricanes can affect where you live and work, and how the weather could impact you and your family.

Develop an emergency plan and practice how and where you will evacuate if instructed by local emergency management officials.

Create and maintain a disaster supply kit complete with enough water, non-perishable food and medications to last several days.

Learn how to properly secure your home against hurricanes. If your home is equipped with hurricane shutters, ensure that they are in proper working order before a storm threatens to strike.

If you have a generator, get fuel for it - enough to last three days or longer.

Monitor local weather forecasts and obtain a NOAA Weather Radio.

During a storm:

Stay inside your home away from windows and glass doors. Find a safe area inside your home such as an interior room, a closet or bathroom on a lower level.

If flooding threatens your home, turn off electricity at the main breaker.

If your home loses power, turn off major appliances such as the air conditioner and water heater to reduce damage.

Do not go outside. Weather conditions can change rapidly with lightning, wind and a multitude of other hazards exist.

After a storm:

Remain indoors until an official "all clear" is given.

Do not touch fallen or low-hanging wires of any kind under any circumstances. Call police or utility companies immediately to report hazards such as downed power lines, broken water or gas mains and overturned gas tanks.

Once power is restored, ensure refrigerated food has not spoiled. Spoiled food is the cause of much sickness two days to a week after the storm.

Do not operate charcoal grills, propane camping stoves or generators indoors for any reason. This includes inside garages, screened enclosures, or near open doors and/or windows.

When it is safe to do so, remove hurricane shutters from windows and doors. These should not be left in place for any reason. Doing so may prevent early detection of the presence of a fire, hinder firefighting efforts or prevent your family from escaping the home in the event of a fire.

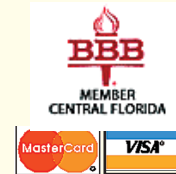

Internet Phishing Scams

Signing documents electronically saves time and makes it easier for people to close contracts, sign mortgage or other legal documents, and fill out tax forms without making trips to the bank, post office or other courier services like FedEx and UPS. But electronic signatures can also come with risks.

Scammers have launched phishing attacks designed to mimic emails from document-signature companies in an effort to trick people into giving up their personal and financial information. And these phishing attacks could likely increase as the U.S. continues to deal with the COVID-19 pandemic. These scams can expose the key financial information of consumers, and give cybercriminals access to bank accounts and online credit card portals.

Fortunately, consumers can avoid falling victim to these scams if they understand how to recognize some of the telltale signs of phishing emails. Often the phishing email claims to come from "DocuSign Electronic Signature" and uses the email address of docusign@milaromanoff.com. The subject line is usually a variant of "You received invoice from DocuSign Electronic Signature Service." Typically the emails contain links to a malicious Word document that, if you run it, will download malware to your device.

If you click on the links in the DocuSign phishing emails, you'll be taken to different websites that request you to enter personal and financial information. If you provide this information, you'll be sending it directly to scammers, who can

then use it to access your bank account, credit card portals and other key financial sites.

There are several clues that a DocuSign email is a scam:

- **You haven't requested any documents.** Be wary if you receive an email stating that you have documents to sign. If you haven't requested any documents, it's likely a phishing attack.

- **You don't recognize the sender.** If the email comes from a name you don't recognize, delete it. You shouldn't be receiving signature requests from strangers. If individuals or businesses legitimately want you to sign a document, they should contact you beforehand, letting you know that a signature request is on the way.

- **Check those links.** You should never click on a link in a random email. Always check the URLs of those links. You'll often find that they aren't links to DocuSign but to other companies. That's a sure sign of a scam.

- **Watch for misspellings.** Scammers often send their phishing attacks from emails that are close to but not exactly the same as those used by legitimate companies. For instance, instead of coming from email addresses ending in @docusign.com, they might come from ones ending with @docusgn.com or @docus.com.

Don't fall victim to phishing attacks. Don't just read the Subject Line when you receive an email. Make sure that you take the above precautions to help protect your information, and also add device security to your smartphones and tablets.

Monthly Tax Update

This month, I believe some of us will be incurring debt cancellation due to corona virus financial distress. Here is some information related to the cancellation of debt (COD).

If you have a financial lender (lender) discharge part or all of a debt you were liable for, you may owe income tax on the amount being discharged. This is because certain debts being cancelled or forgiven by a lender results in taxable income to you, even though you have not technically received any money in hand from the debt forgiveness.

Generally, debts discharged or canceled by a lender must be included in your taxable income. Debt forgiveness income, or COD income, is the amount of debt a lender discharges or cancels. This lender cancellation of debt will generally result in income to the borrower unless a specific exception applies.

In general, if the amount forgiven or canceled is \$600 or more, the lender must issue you the IRS Form 1099-C, Cancellation of Debt, showing the amount of debt canceled. Even though the creditor has issued Form 1099-C, you may be able to claim an exclusion from income for the canceled debt.

Okay, let's look at the exclusions. COD income is not always taxable. The most common situations in which cancelled debt does not result in taxable income includes the following: The debt has been discharged through a bankruptcy proceeding under Title 11; insolvency (your total debts exceed your total assets); qualified principal residence debt (limited to \$2 million (\$1 million for married taxpayers filing separately)); the debt is due to a qualified farm expense or farm property (qualified farm debt); and the debt is due to certain real property used in a trade or business (qualified real property business debt).

Other exclusions may apply to student loans, disaster victims, gifts, general welfare payments and deductible payments.

If the COD is determined to be non-taxable, then there is what is called a reduction of attributes. This means the canceled debt being excluded from income may require the taxpayer to reduce their tax attributes, such as reducing their basis in the property. The reduction of attributes must be reported on Form 982, Reduction of Tax

Attributes Due to Discharge of Indebtedness, and included with your federal income tax return. If you do not reduce attributes, the IRS may take the position the COD is taxable income.

Now, let's take a look at another circumstance involving a non-recourse loan. This is a loan in which your lenders' only remedy, in case of default, is to repossess property used as collateral for a loan. In these cases, it may result in other tax ramifications and not covered in this article. However, mortgage debt forgiveness being discharged by the lender is excluded from COD income and therefore does not result in taxable income to homeowners. This is generally referred to as "qualified principal residence debt." The cancellation of qualifying mortgage debt is excludable from income if it is incurred with respect to the taxpayer's principal residence for "acquisition" debt forgiven on or after January 1, 2007 and before January 1, 2021. Acquisition debt is indebtedness secured by the residence and incurred in the acquisition, construction or substantial improvement of the residence. The exclusion is limited to \$2 million (\$1 million for married taxpayers filing separately). Debt forgiven on a second home or rental property does not qualify.

Finally, credit card and car loan debt are

noticeably absent from the specific exceptions to COD income. These are two of the biggest COD items. Credit card debt or an unpaid debt on a car loan, forgiven by the lender, is included in gross income unless the debtor is bankrupt or insolvent. The lender will report the amount of forgiven debt on Form 1099-C and Form 982 will be filed by you.

Debt discharged is income when no exception is permitted and included as cancelled debt in your gross income on the "Other Income" line in your tax return.

On the Road With Rose Mosquito Lagoon Merritt Island

Again I'm hoping by the time this is published that we will be more able to get out and about, but the Mosquito Lagoon is more than worth the visit at any time.

Located in the Merritt Island Wildlife Refuge, which is part of the Canaveral National Seashore, Mosquito Lagoon is a bit of a drive to get to but it's like stepping back in time to old Florida.

Take U. S.1 north from PSJ or the Groves, turn east (right) onto Garden St., going over the beautiful Max Brewer Bridge and passing Parrish Park, which is made up of many great places, we are able to just pull off the road and enjoy all the water sports our great area has to offer. This area is not well known, but a great place to take the kids, floating stuff, fishing poles and lunch for a great day of healthy social distancing fun.

Continue to drive approximately 8 miles to the only stop light. You'll pass several marked hiking paths and Black Point Wildlife Drive, a road leading through several of Florida's elevations from scrub to pine. Keep a sharp eye out. I've spotted eagles, alligators and other wildlife

every time I have taken the drive.

Turn left at the light to get to Mosquito Lagoon. Going straight would take you to Playalinda Beach. You can see the gate while stopped at the light. Please take your time driving approximately 9 miles to Haulover Canal. At first look, the landscape appears to be just empty scrub, but you can usually catch a beautiful black racer slithering across the road, a raccoon peeking out from under a palmetto fan and a myriad of birds riding the wind currents.

In the middle of all this untouched beauty is the Sandler Education Outpost, an area dedicated to environmental education program, It has restroom facilities, fire pit with seating, picnic tables, exploration areas and shore-line access. Scout troops, 4-H, class field trips, or other clubs, groups or organizations can book the pavilion and surrounding amenities for field oriented activities, marine studies or habitat exploration. If you stop and read the historical marker you'll learn of Sandler's connection to our famous fruit.

I couldn't find a name plate for the draw bridge, but just past it is the Manatee Viewing Area. A section of the Haulover Canal in this area

is a gathering point for manatees most of the year. They seem as curious about us as we are about them and will spend many moments at the top of the water just staring and blowing. Please do not feed them. Produce from the store has chemicals in it and can make them very ill.

The fishing is really good here early in the morning and evenings.

Take a left onto Haulover/Mosquito Lagoon Rd., stopping at the display map to learn more about the area, and pick up a pamphlet or better yet, take a couple so you can share.

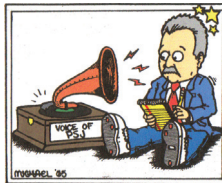
The road is not paved, which makes it good for taking in the various plant life including Australian pine trees, all of which is different from the palmetto scrub surrounding it.

To the left of a turn in the little road is a very interesting bunker type structure covered by vines and weeds that fascinated me, but I don't advise clumping around it, because this is a prime spot for Florida rattlesnakes and chiggers. Considering there used to be families living in the area in the late 1800's until NASA moved in, ya' just never know what it could be.

There are breaks in the pines just made for

Depending on the time of year, the night tours include bioluminescence areas.

- Barber Shops, beauty salons, nail salons and personal care services

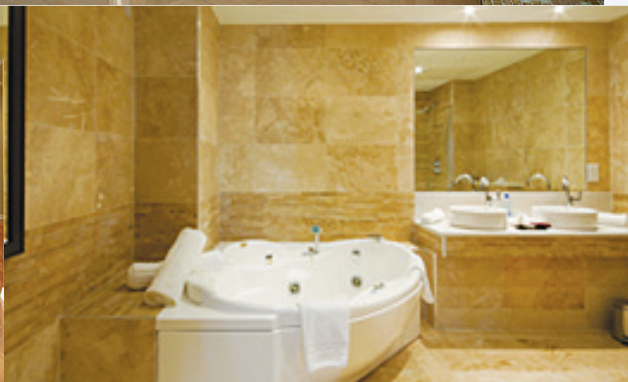

3. Look Beyond the Brown Spots

Skin cancer lesions and spots can form in different colors, sizes, and shapes. While it's important to get your yearly head-to-toe check, don't overlook moles or birthmarks that are starting to change or new spots that you've never seen before.

Give yourself a "spot check" by knowing the ABCDE's of skin cancer:

Asymmetry: One side of a mole or birthmark does not match the other side.

Border: Irregular or scalloped borders.

Color: Colors vary and may have shades of tan, brown and black or sometimes white, red, pink or blue.

Diameter: If the spot is larger than 6mm (the size of a pencil eraser) however, sometimes it can be smaller.

Evolving: If the mole or skin lesion is suddenly changing size, shape and/or color.

If you notice any spots that fit the above description, make an appointment with a doctor to have it further examined.

4. Apply Sunscreen Often

When spending the day in the sun one application of sunscreen isn't going to protect you all day long. Remember to re-apply at least every two hours, especially if you will be swimming or sweating. This also goes for sweatproof and waterproof sunscreen. Your skin will thank you!

5. Men are Diagnosed More Than Women

It is estimated that 91,270 new cases of melanomas will be diagnosed by the end of the year (about 55,150 in men and 36,120 in women). Here are some reasons why men are more at risk:

They spend more time in the sun throughout their lifetime.

They're more likely to have occupations that require them to be in an outdoor environment.

Their skin care products such as lotions and creams do not come with sunblock as opposed to the vast amount for women on the market.

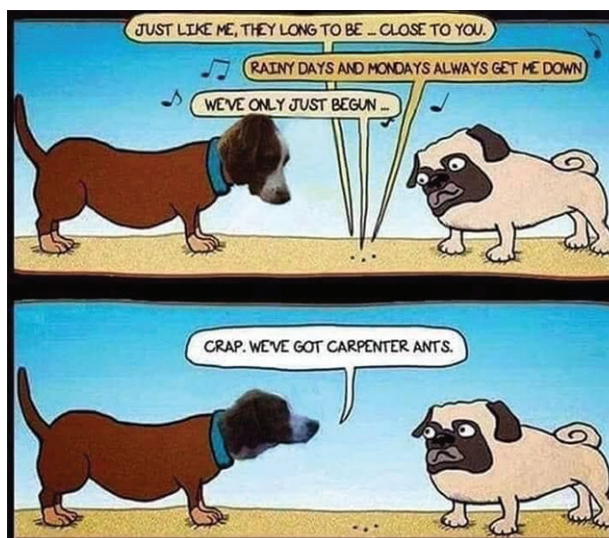
