### Good Day! by Maureen Rupe

The applicant is seeking to add a Conditional Use Permit (CUP) for alcoholic beverages (full liquor) for on-premises consumption in conjunction with a sports bar. The sports bar space encompasses the southeast portion of the building; 75 feet in width by 50-foot in depth, within an existing shopping center.

No one spoke for the change, but it was approved unanimously. The change is before the county Planning and Zoning board on 1/13/20 and is before the Brevard County Commission on 02/06/20.

### **Liquid Natural Gas (Continued)**

My story last month got a bit of attention from others in the country who are studying LNG and its negative health aspects. I was sent the following, which I have received permission to include without modification:

proposed LNG export facility on a 22-acre Site in Titusville will be in violation of CFR Title 49, Part 193.2155(b) unless the company obtains a Variance from the Pipeline and Hazardous Materials Safety Administration. Before PHMSA will consider approving the Variance, PHMSA is requiring an Environmental Assessment.

The problem with small-scale, inland LNG export facilities is that no federal agency has jurisdictional authority under the Natural Gas Act for the siting, construction, operation and maintenance of these facilities. "Small-scale" is based on volumes of LNG produced. The Federal Energy Regulatory Commission has abdicated Congressional jurisdictional authority over these facilities. There was no formal rule making (see attached).

at 6800 NW 72nd St. in Miami skirted NEPA review by the U. S. Department of Energy by claiming a Categorical Exclusion (B5.7) that went unchallenged by the DOE. This Exclusion cannot be used for "new construction." The Miami export facility was "new construction."

"If constructed, American LNG Marketing's LNG Holdings (Florida), owner/operator of the facility, did not file an application with the DOE to export LNG. Rather, LNG Holdings/New Fortress Energy affiliate American LNG filed the application. American compared its operation to Carib Energy that received authorization from the DOE to export LNG to non-FTA nations from the proposed Floridian Natural Gas Facility proposed for Indiantown. The big difference between Floridian and LNG Holdings, however, is that Floridian is a FERC-jurisdictional project, and FERC performed an Environmental Assessment for the project. FERC is not involved with any of the New Fortress Energy LNG inland export projects.

In 2012, Fortress Investment Group wanted to hire a data control person. The job description said Fortress planned to develop a nationwide The American LNG export facility located LNG production and distribution (i.e. rail) business. Michael Reininger, past president of AAF, served as AECOM's Chief Development Officer. AECOM was involved with constructing the TRANSCO Natural Gas Pipeline that feeds the Sabal Trail Pipeline and Southeast Market Connection that terminate in Indiantown, Martin



County. Another inland LNG facility has been proposed for Crystal River, Florida. AECOM will serve as EPCM for the LNG export project.

We regulate propane in Florida, but not LNG. This is absurd."

CeCe Scofield is a member of the Coalition for Responsible Siting of LNG Facilities in Fall River, Massachusetts, and served as a founding member and President of Citizens for Environmental Justice of Greater Fall River, Inc., a 501c3 nonprofit. She moved to Florida in 2009.

CeCe Scofield also sent me a proposal for LNG regulation in Florida. I am including it in its entirety without modification.

"PROPOSAL FOR FLORIDA DEPART-MENT OF AGRICULTURE TO REGULATE LIQUEFIED NATURAL GAS (LNG) PRO-DUCTION, STORAGE AND TRANSPORT OPERATIONS IN THE STATE OF FLORIDA **PROPOSAL** 

Criteria must be established for the safe siting, construction and operation of LNG facilities and require that such facilities obtain a permit from the Florida Department of Agriculture to protect public health and the environment in Florida.

Definitions from 49 CFR § 193.2007:

LNG facility means a pipeline facility that is used for liquefying natural gas or synthetic gas or transferring, storing or vaporizing liquefied natural gas.

LNG plant means an LNG facility or system of LNG facilities functioning as a unit.

Permit Application Process should include:

- The location of the proposed facility
- 2. A description of alternative locations for the proposed facility, if any
- 3. Demonstration that the proposal is compatible with surrounding environment and safety of neighboring populations
  - 4. The need for the proposed facility
- 5. Specification of tank manufacturing design standard and design capacity for each tank
- 6. The facility capacity, including volume stored in loaded 10,000-gallon ISO containers
  - 7. Expected sources of natural gas
- Possible environmental impacts of the proposed facility and facility features with procedures to mitigate
- 9. Report prepared by independent qualified D. person that evaluates capability and preparedness

of fire departments in the vicinity of the proposed facility who would respond to a release of LNG or fire involving LNG, detailing any deficiencies with cost estimate for remedying

- 10. Proof of liability insurance covering proposed LNG operations
- 11. Written listing of applicable NFPA (National Fire Protection Association) requirements
  - 12. Maps of floodplains
- 13. Such other information as Florida Department of Agriculture determines is necessary to approve or deny Permit request.

Criteria for Siting and Operations of Facilities:

- 1. All LNG facilities must comply with the requirements of the provisions of the current edition of NFPA 59A Standard for the Production, Storage, and Handling of LNG.
- 2. Transfers of LNG to trucks or rail cars must also comply with the applicable provisions of the October 1, 2013, edition of the United States Department of Transportation's Pipeline Safety Regulations, 49 CFR Part 193, Subchapter



3. Facilities that transfer LNG to and from marine vessels shall be designed, built and operated in accordance with 49 CFR Part 193, Subchapter D and/or the July 1, 2013, edition of the United States Coast Guard's Navigation and Navigable Waters Regulations, 33 CFR Part 127, as applicable.

4. Florida Department of Agriculture will determine if the information provided indicates need for additional training, personnel or equipment to enable local fire departments to respond effectively to any release or fire involving LNG at the facility. If additional training, personnel or equipment is needed, it shall be provided by the applicant before beginning operation of the facility.

5. Florida Department of Agriculture shall consider the physical, flammability and explosivity characteristics of LNG in determining compliance, including risks to persons and property in the neighboring area of an LNG facility and risks from transportation accidents.

Public Participation:

Hearings, comments, or participation by Federal, State or local government bodies or members of the public relative to any permit proceedings, shall be conducted.

New York State adopted Regulation 6 NYCRR Part 570 to implement safe siting, operating, and transportation requirements for LNG facilities in New York. See:

In another story, an article in the Financial Times, titled, "Trump Administration nears decision on LNG shipping by train," federal approval may be near. The article stated the industry needed the ability to reach areas limited by pipeline constraints for shipping low volumes of LNG. The article stated the deadline for comments is Monday, but the article didn't give a date. It stated President Trump request a national LNG by rail policy from the transportation department in an executive order last year on energy. Opponents question the safety when one rail car can expand to over 2,500,000 cu feet if the car was punctured. Opponents also questioned the administration's putting so much to enable greenhouse gas development when we should be putting all our energy into addressing climate change.

### **Monthly Tax Update**

Wow, have you seen the new 2020 W-4, Employee's Withholding Certificate? The new form removes the traditional filing statuses of Single, Married, and Married at the Single higher rate. It's now Single, Head of Household, and Married. Also, there isn't any consideration to your number of exemptions. So, what do you do now?

You have the right to retain your pre-2020 W-4, or complete a new W-4 following the instructions and method of arriving at what to enter on the form. I believe everyone is confused from the employee to the employer. Basically, you have withheld taxes or you're exempt. You really have no way of reducing the amount of withheld taxes without completing the new W-4. If you complete your new 2020 W-4 and just check single or married, then the amount of withheld taxes are already predetermined and set. However, if you have other circumstances where your withheld taxes should be more or less, you'll have to complete page 3 to determine the additional adjustments provided. These circumstances include two earners, child tax credits, education credits, dependents and other tax credits.

My recommendation would be to complete the W-4, submit it to your employer and review the withheld taxes to evaluate if the amount withheld is correct or not. If it seems your coming up short, you can elect to have an additional amount withheld on page 1, line 4c. On the other hand, if the amount is more than necessary, you'll have to disregard the amount you entered on page 1, line 4b, and increase the amount of the deduction. This isn't right, but it would work.

Next, I would also suggest you'll need to consult with your tax advisor for resolving your confusion.

Okay, with that said, I need to address the employer. In Publication 15-T, you'll find two sets of tables towards the back of the publication. The first set is the withholding tax tables if the employee has submitted a 2020 W-4. The second set is for the employee electing not to change their W-4, submitted prior to December 31, 2019, and this set you'll be familiar with. Both sets are pretty much cut and dry. You'll just have different columns in the first set. You'll have to be alert to the different classifications and whether they checked box 2 or not. Again, you may need to consult with your tax advisor for resolving your concerns.

We have also found some of the payroll

software doesn't provide for ways to enter the information from pre-2020 W-4's and your only option is to enter the information from the new 2020 W-4. I don't have a recommendation for a solution except to contact the software developer and request their assistance.

I guess the biggest concern is to inform your employees they need to be aware of the adjustments taking place. They will need to complete a tax evaluation and make sure adequate withholding is being done to prevent them from incurring a tax liability when completing their tax return. It is our belief the government is trying to reel in some of these large refunds and large tax liabilities making everyone, pretty much, pay in what they only need; no more or no less. Good luck!!!

### Social Security Administration and its Inspector General **Announce New Online Reporting Form for Imposter Scam Calls**

Andrew Saul, Commissioner of Social Security, and Gail S. Ennis, the Inspector General for the Social Security Administration, announce the launch of a dedicated online form at https://oig.ssa.gov to receive reports from the public of Social Security-related scams. These scams—in which fraudulent callers mislead victims into making cash or gift card payments to avoid arrest for purported Social Security number problems—skyrocketed over the past year to become the #1 type of fraud reported to the Federal Trade Commission and the Social Security Administration.

To combat these scams, Social Security and the OIG will use the new online form to capture data that will be analyzed for trends and commonalities. The OIG will use the data to identify investigative leads which could help identify criminal entities or individuals participating in or facilitating the scams. Ultimately, these efforts are expected to disrupt the scammers, help reduce this type of fraud and reduce the number of victims.

"We are taking action to raise awareness and prevent scammers from harming Americans," Commissioner Saul said. "I am deeply troubled that our country has not been able to stop these crooks from deceiving some of the most vulnerable members of our society."

Commissioner Saul and Inspector General Ennis encourage the public to use the new online form to report Social Security phone scams including robocalls and live callers, as well as email, text and in-person scams. The form allows people to create a unique Personal Identification Number (PIN), so if OIG contacts a person about their report, they will know the call is legitimate.

"Awareness is our best hope to thwart the scammers," said Inspector General Ennis. "Tell your friends and family about them and report them to us when you receive them, but most importantly, just hang up and ignore the calls."


Social Security employees do occasionally contact people-generally those who have ongoing business with the agency--by telephone for business purposes. However, Social Security employees will never threaten a person, or promise a Social Security benefit approval, or increase, in exchange for information or money. In those cases, the call is fraudulent and people should just hang up.

Generally, the agency mainly calls people who have recently applied for a Social Security benefit, someone who is already receiving payments and requires an update to their record, or a person who has requested a phone call from the agency. If a person is not in one of these situations, they normally would not receive a call from the agency.

Social Security will not:

- · Tell you that your Social Security number has been suspended.
- · Contact you to demand an immediate payment.
- · Ask you for credit or debit card numbers over the phone.
- · Require a specific means of debt repayment, like a prepaid debit card, a retail gift card, or cash.
- · Demand that you pay a Social Security debt without the ability to appeal the amount you owe.
- · Promise a Social Security benefit approval, or increase, in exchange for information or money.

If there is a problem with a person's Social Security number or record, in most cases Social Security will mail a letter. If a person needs to submit payments to Social Security, the agency will send a letter with instructions and payment options. People should never provide information or payment over the phone or Internet unless they are certain of who is receiving it.

The Social Security OIG will also continue to take reports of fraud, waste, and abuse in Social Security's programs and operations. A separate online form for those reports remains available at their website.

### On The Road With Rose

### The Sams House at Pine Island

I don't like to crow but I don't believe there is another place on earth that can brag about having everything from the earliest native American relics to pioneer homesteads - complete with structures and documented histories - to the latest and most futuristic project on earth; space exploration! All in less than a fifty square mile radius including waterways! Some of the aforementioned square miles consist of the Sams house and surrounding area bordering North Tropical Trail in Merritt Island.

Either North or South Tropical Trails make for a wonderfully peaceful afternoon drive, many places giving a glimpse into what Merritt Island used to be. From north area swampland to Dragon Point, you are never more than a couple of miles from our scenic rivers and lagoons, not to mention the historically significant Barge Canal.

The Sams house is the oldest home in Merritt Island and has been in continuous use since it was constructed in Eau Gallie in 1875. Then the family decided the area wasn't working for them, so the industrious family found fertile land for their citrus groves in what was then Merritt's Island. They dismantled the one room house, floated it up the Indian River lagoon and reconstructed it, all by hand with rudimentary tools. The original cabin and subsequent larger home still stand on the same sites. The cabin is now air conditioned for visitor comfort, open for visitors and houses artifacts from the native burial ground and pioneer settlement days. The separate kitchen and outhouse are no longer standing. There are modern public bathrooms available, however.

Studying the old tools and artifacts, you know there are many stories just waiting to be told about all members of the Sams and other families' hard work scratching out a homestead, chopping trees, pulling bushes, tilling the earth all by hand.

After perusing everything the cabin has to offer, there are several walkways ambling through plantings of fruits, vegetables and trees utilized by the pioneers. They can be enjoyed by all, but the children will enjoy the prehistoric site leading through the ages... including a fifteen-foot sloth.

Hands on exhibits include sifting for animal

bones and shark's teeth. There is also a screened room for Saturday presentations by speakers or EEL staff.

The nine miles of nature hiking trails are what my grandkids enjoyed the most. We have hiked a different trail each time we visited and have seen a family of hogs run right past us and an alligator taking a nap off the trail. Other visitors have reported seeing otters, bobcats, fox and coyotes. Depending on the time of year, there will be various plants blooming and fruit ripening, some a little surprising. Most of us don't know that palm flowers have a pleasant fragrance. It's easier to enjoy when you're not surrounded by civilization and it's easy to understand how beauty berry got its name.

Walking the trail to the lagoon, we were most impressed by the knowledge that we were walking in the very steps someone, usually a young family member, had to travel every time they fished or hunted for dinner or needed river water for something.

Please do not leave the property without a visit to the native American burial mound. The plaque is most informative and if you stand very

still you can almost imagine them gliding through the underbrush hunting or utilizing a hollowed out log for travel and fishing.

One of the monthly activities will be a Pioneer Day on February 8th. There will be demonstrations, tours, crafts, farmers market, kid's games and more

Workers are happy to arrange field trips for groups of all ages. There is no charge for parking or visiting, but donations are much appreciated and there is sure to be something for each member of your family to enjoy. Hiking and discovering are wonderful ways to make lifetime memories.

Insect spray is recommended during warmer weather and please do not take anything but pictures nor leave anything but footprints.

**DO** control your cholesterol and triglycerides. High levels of cholesterol and triglycerides can clog your arteries and raise your risk of heart attack.

weight can increase your risk for heart disease because it is linked to other risk factors, including high cholesterol and triglyceride levels, high blood pressure and diabetes

**DO** eat a healthy diet. Limit saturated fats, salt and sugars. Eat plenty of fresh fruit, vegetables and whole grains.

**DO** exercise regularly. Exercise strengthens your heart, improves circulation, cholesterol levels and blood pressure, and helps with weight management. Aim for at least 30 to 60 minutes of moderate exercise daily.

**DO** limit alcohol. Too much alcohol can raise
