

### **Good Day!** by Maureen Rupe **Right to clean air and water, and lands free of pollutants.**

The Brevard County Charter is basically our county's constitution. It is the rules that will guide the county on how government is run in our county. It takes precedence as long as it doesn't conflict with the Florida or United States Constitution. I am on the 2016/2017 Brevard County Charter Commission; a 15-member body tasked with looking at possible changes to improve the Brevard Charter brought forth by citizens of Brevard County.

As mentioned last month, I proposed a charter amendment on the right of Brevard citizens to clean air and water, and lands free of pollutants. The Brevard County Commission, for the past 30 years, have ignored the warning signs; they should have banned septic and fertilizers with nitrogen and phosphorus near water bodies. It would have been relatively easy.

As it is, we are facing a dying lagoon. During discussion, I stated I was open to word changes

if the message was the same. It was not meant for the Brevard County Commission to bear any monetary burden, but for the County Commission to become a champion for the Lagoon, involved in saving it's life; something we have never had, a champion to discuss with our legislators the fact they have responsibilities. For example, our legislature passed an inspection for septic tanks and repealed it 2 years later. The legislature six years ago passed a law that septic tank sludge could no longer just dump on the land, but allowed six years to arrange new process. Six years later there is still no process in place and the septic pump out industry spent the last six years trying to repeal that law.

It's not like this is a new subject. Orange County's Charter states in section 704, "(2) protecting the environment by prohibiting or regulating air or water pollution, ..." Volusia County Charter states in Section 202.2, Security of Citizens' Property Rights "(3) Abuse the environment. The county shall not permit the development or use of land or the commission of other acts by persons,

partnerships or corporations which will tend to destroy or have a substantially adverse effect on the environment of the county. Such destruction or adverse effects may include any or all of the following. (a) Pollution of the air, land or water by foreign substances, including noxious liquids, gases or solid wastes. (b) Pollution of the air, land or water by the creation of potentially harmful conditions therein, including the creation of unnecessarily injurious heat, noise or odor. What is wrong with either of these approaches?

The right of Brevard Citizens to clean air and water, and lands free of pollutants - It's a simple statement that everyone agrees with. As for my suggested amendment to the Charter, the proposal failed 14 to 1. I was the one. Is this an extension of some people's concern, not for the lagoon, but for business and economic reasons? Everyone who is thinking of their own affairs are not really concerned about the river. You cannot be politically right, if it is morally wrong. I guarantee if this was on the ballot, it would have passed. ICh.70-966, Laws of Florida (Sp. Acts) Art. II, '

### Land Purchased with MSTU Funds

The next amendment I submitted was the "Sale or Transfer of Ownership of Land Purchased with MSTU Funds." This amendment had Port St. John and Canaveral Groves' future in mind, as discussions on fixing our roads have suggested the county sell or lease properties. This amendment would have prevented that from happening. Their discussing on selling/leasing county property could lead to selling our Community Center, Fay Lake Park and the Space Coast Sports Complex. Besides continuing to pay funding for the North Brevard Parks and Recreation, we chose to tax ourselves to purchase these properties and continue to do so, paying to maintain those properties. The County Attorney states this is completely legal.

Environmentally Endangered Lands were purchased with MSTU funds. Brevard County residents voted twice to keep EELs purchases going. Selling EEL property has been discussed at the Brevard County Commission, but was dropped

as the majority of the properties are co-owned by the state of Florida, so besides coordination, the county would not receive all sale funds.

During discussion, it was mentioned my amendment didn't mention limitations on how votes would be conducted, and I stated I could amend it to ensure the area voting to purchase the property would vote on the property's sale or lease. This amendment was turned down by the majority of the Commission. The primary argument, which was ridiculous, was what if we have an emergency. The County Commission had to have ways to raise funds. If the county commission needed to raise funds in an emergency, selling property would be the least beneficial, as the County Commission could only raise pennies on the dollar on any property in an emergency situation.

Another reason brought up was that the county owns too much property now, but if getting rid of property, why land already receiving funds to pay for maintenance? It would make more sense to sell the County Commission Chambers instead

of any of our parks.

### Florida proposing more Benzene in our water

According to the thinkprogress.org website May 16, 2016 article by Natasha Geiling, titled "Florida Proposes Tripling Amount Of Benzene That Can Be Polluted Into State Waters," Florida is proposing raising the limit on the Florida Department of Environmental Protection (DEP) to triple the amount of benzene allowed in our rivers and lakes. According to the article, "The DEP's proposal to raise allowable levels of benzene -- often found in fracking waste water -- has led some environmentalists to accuse the DEP of revising the standards to help make Florida a more attractive location for fracking companies." The article said Fracking has been debated a lot lately,

with Brevard County even banning fracking. This year, the Florida Legislature tried to pass a bill allowing fracking any place in Florida as early as 2017, and would have prevented any local bans on fracking. Luckily, the bill was killed by the Florida Senate.

The article quoted the following at a recent public hearing on the subject: "The DEP should be pushing for even more stringent criteria than what we have now rather than trying to weaken them," Dr. Ron Saff, a Tallahassee allergist and immunologist, said during the workshop. "Your job is to protect Floridians, not to poison us."

## Illegal Gopher Tortoise Burial

Last week, I had a call from a gentleman in Titusville who was extremely upset. He lived near some new construction and had watched the developer bury alive some Gopher Tortoises, then place a house on it. Even the land next to the house had Gopher Tortoises buried on it. He said Fish and Wildlife told him they would meet

him at the site. Someone had told him to call me.

I called the City of Titusville Council members and they told the City Planner to attend at the site. Fish & Wildlife told the man if he saw such a thing again to immediately call the police, as it is illegal. The suffering of these tortoises is immense, as it takes up to six months for them to suffocate.

If anyone sees construction starting on sandy scrub near you, please call Fish & Wildlife. Some developers do not want to pay to relocate tortoises, which can be hefty if a lot of tortoises are on the property as each tortoise has a burrow of its own. The Gopher Tortoise is also a Keystone Species, which means during times of wildfires or hurricanes, other species will use their burrows to survive, including snakes, mice and some endangered animals.

Sorry, but my article this month is not as long. I fell and broke my arm and my nose. Not good. It has given me a new admiration for the disabled. Some are a lot more afflicted than myself and I am healing.

## Monthly Tax Update

You may be tempted to forget all about your taxes since you've filed your tax return. But, you now need to start thinking about your taxes for this year. If you start your tax planning now, you may avoid a tax surprise. Here are some IRS tips to give you a leg up on next year's taxes:

Take action when life changes occur. Some life events can change the amount of tax you pay. This would include a change in jobs, marital status, birth of a child, family members move in with you, retirement or possibly disability. If it happens, you may need to change the amount of tax withheld from your pay. To do that, file a new Form W-4, Employee's Withholding Allowance Certificate, with your employer or if self employed, make adjustments to your estimated tax payments.

You may also need to report changes in circumstances to the Health Insurance Marketplace. If you enrolled for insurance coverage through the Health Insurance Marketplace in 2016, you should report these changes in circumstances when they happen. Report life events such as the ones previously mentioned to help you avoid

getting too much or too little financial assistance in advance.

Keep your records safe. Put your 2015 tax return and supporting records in a safe place. If you ever need your tax return or records, it will be easy for you to get them. For example, you may need a copy of your tax return if you apply for a home loan or financial aid. You should also use your tax return as a guide when you do your taxes next year.

Stay organized. Make tax time easier. Have your family put tax records in the same place during the year. That way, you won't have to search for misplaced records when you file next year. Also, start shopping for a tax preparer and hire a tax preparer to help you with tax planning. Be sure to choose your tax preparer wisely. Use the Directory of Tax Return Preparers tool on IRS.gov to find tax preparers in your area with the credentials and qualifications that you prefer.

Evaluate if you're able to itemize your deductions or not. If you claim a standard deduction on your tax return, you may be able to lower your taxes if you itemize deductions instead.

Always stay informed. Subscribe to IRS Tax Tips to get emails about tax law changes, how to save money and much more. You can also get Tax Tips on IRS.gov or IRS2Go, the IRS mobile

app to receive tax information that will broaden your tax knowledge. Early planning may pay off with savings when you file your taxes next year.

Now, let's give consideration to special tax rules that may apply to some children who receive investment income. The rules may affect the amount of tax and how to report the income. Here are five key points to keep in mind if your child has investment income: Investment income generally includes interest, dividends and capital gains. It also includes other unearned income, such as from a trust. There's a Parent's Tax Rate. If your child's total investment income is more than \$2,000, then your tax rate may apply to part of that income instead of your child's tax rate. See the instructions for Form 8615. Parent's Return may be affected.

You may be able to include your child's investment income on your tax return, if it was less than \$10,000 for the year. If you make this choice, then your child will not have to file his or her own return. See instructions for Form 8814. A Child's return may be required. If your child's investment income was \$10,000 or more in 2016, then the child must file their own return. File Form 8615 with the child's federal tax return.

Finally, your child may be subject to the Net Investment Income Tax and they must file Form





## Do I need a fishing license?

In general, you need a freshwater license to take freshwater fish and a saltwater license to take saltwater fish, unless:

Seniors and children - Children under the age of 16 and FL resident seniors who are 65 or older are not required to purchase most recreational licenses. However, officers may ask exempt children and seniors for proof of age. Seniors should also be prepared to show proof of residency. Nonresident seniors need to have a Florida recreational fishing license and permits, unless fishing with a charter captain from a charter vessel or otherwise properly licensed vessel or from a licensed pier.

Food stamp, temporary cash assistance, or Medicaid recipients - The "food stamp" exemption only applies to Florida residents who are saltwater fishing from the shore or a structure attached to the shore. It does not apply to freshwater fishing or to saltwater fishing from a vessel or when swimming or diving.

Obviously if you are fishing in pure fresh water where no saltwater species live, you need a freshwater license and likewise if you are fishing in the ocean you need a saltwater license.

However, when you get into estuarine type areas where salt and fresh water commingle and fish of both types can be found the issue becomes less clear. The interpretation of the rule is:

1. You need either a freshwater, saltwater or combination license (or appropriate exemption) to take fish (take is legally defined as taking, attempting to take, pursuing, molesting, capturing, or killing any fish, or their nests or eggs by any means whether or not such actions result in

obtaining possession of such fish or their nests or eggs).

2. If you are using species specific gear, your license should be appropriate (e.g., freshwater or saltwater) to the species you are targeting, and

3. Annual recreational fishing licenses expire one year from the date issued. The expiration date is printed on all the licenses.

Otherwise you need an appropriate type license to keep your catch and must immediately release any species for which you are not licensed. License requirements follow the species of fish, regardless of where they are caught. In other words, if you only have a freshwater license and are primarily fishing for largemouth bass or bream (freshwater species) in a river, but happen to catch a red drum (a saltwater species), you must immediately release the red drum.

A pleasant time can be turned into a nightmare in seconds. These steps will help make sure your dream vacation isn't derailed by a financial mishap.

Keep your cards in the clear. A week before your trip, call your bank and credit card company to inform them of your travel plans, including where you are going, as well as when and how you plan to use the cards. This will help avoid the companies flagging your cards for fraudulent use.

Transfer money from savings to checking. If you leave the money you saved for vacation in your savings account, you may struggle to access it from an ATM.

## Are Your Passwords Hack-Proof?

According to a 2015 study from CrossMatch, 75 percent of all account hacks are due to weak or stolen credentials. This poses the important question, are you doing enough to lessen your password risk? How Are The Crooks Doing It?

**1. Online Guessing** - One of the top ways that a criminal is able to obtain your passwords is by simple online guessing. There is a short list of commonly used passwords that crooks use to gain access to consumer accounts. These easily guessable passwords include:

123456, password, 12345, 12345678, qwerty, 123456789, 1234, baseball, dragon, football, 1234567, monkey, letmein, abc123, 111111, mustang, access, shadow, master, Michael, superman, 696969, 123123, batman and trustno1.

The most common username was "admin."

**2. Offline Cracking** - In some instances hackers are able to steal databases of passwords from poorly secured websites. This is why it is very important to ensure that you do not create accounts on websites that are not encrypted. A safe, encrypted website will read https://, rather than http://. In addition, there is usually a little lock icon right before the URL within your browser.

**3. Structural Patterns** - Research has found that the majority of passwords follow one of 13 password structures. For example, when a person is required to include a number as part of his or her password, they usually put two to four digits at the end of the password. These numbers typically relate to the previous year, or the year of their high school or college graduation.

Use a name, place, or common word such as baseball, football, love, etc.

Capitalize the first letter of the word. For instance "Football," "Love," etc. Add a single number, usually 1 or 2, to the end of the word. For example, Love1 or Baseball2. Substitute vowels with special characters or numbers. For instance B%seb%ll2!

Keep in mind that you should utilize symbols in your password, however, when common symbols are utilized at the end of a common word password, guessing is easier for hackers.

**3. Social Engineering** - Many hackers skip guess work and go right to human sources. It is much easier for a hacker to get you to simply tell them your password or show them. For instance, phishing attacks are utilized to imitate legit websites, and redirect users to a phony site via a link in an email. Users are then tricked into entering their username and password information, giving the hacker access to his or her actual account.

Your credentials can also be stolen by someone simply looking over your shoulder while you are typing in your username and password.

**4. Malware** - Malware is by far the largest contributor to stolen credentials. Malware installs malicious software into computers via credential stealing software such as key loggers that record type strokes.

### How To Protect Yourself

1. Do not use common words for your passwords.
2. Capitalize random letters within your password, rather than just the first letter.
3. Utilize symbols in your password, but try to not substitute obvious symbols such as @ for an a.
4. Change your passwords at least every 30 days.
5. Do not use anything that would be easy for someone to guess, such as a child's name, pet's name, current year, your graduation year, anniversary date, etc. Also try to stay away from the most common passwords mentioned in number one of the first section.
6. Before you create an account on a website, make sure that it is encrypted and secure by checking the URL. Ensure the URL reads https:// instead of http://. In addition, look for the little lock next to the URL.

7. Do not give your passwords to anyone. Make sure that if you write down your passwords you keep them in a locked drawer. Do not keep your passwords on your computer.

8. Before entering your username and password, check to make sure nobody is around looking over your shoulder.

9. Create a different password for every online account you have. This way if someone is able to hack into one of your accounts, all of your accounts do not become compromised.

10. If you get a suspicious email from a company or your financial institution advising you to login to avoid freezing your account, do not click on any links within the email. Contact your financial institution or the company directly to inquire about the email. A company or financial institution will never email and ask you for your username and password. Above all, do not click any links within the email.

### **ALL ABOARD FLORIDA OR NOT!**

The following is a letter from the Army Corps of Engineers to Kolleen Cobb with All Aboard Florida/Bright line in Coral Gables:

Ms. Cobb:

Reference is made to the Department of the Army permit application you submitted to construct an intercity passenger railroad between Orlando International Airport and West Palm Beach, Florida utilizing as much of the existing Florida East Coast Railroad right-of-way as feasible.

The U.S. Army Corps of Engineers (Corps) circulated a public notice for the proposed action on April 11, 2016. The comments received during the public notice period are enclosed. In addition to the numerous letters of objection received, Indian River and Martin Counties have identified data gaps in the dredge and fill plans and wetland delineation maps provided in your Department of Army (DA) application. Several objectors are disputing the Alternatives Analysis defined in the All Aboard Florida (AAF) Final Environmental Impact Statement (FEIS) as well as the public interest of the proposed action. Some objectors have sited increased noise, increased vibration, reduction in public safety and property value reduction as their primary objection.

During the review of the initial DA permit application, the Corps identified discrepancies in the impact assessment figures, functional assessments, indirect impact analysis and compensatory mitigation. These discrepancies were coordinated with Alex Gonzalez of your staff and consultants during a face to face meeting on April 18, 2016.

As you are aware, the Corps must complete its public interest review defined in 33 CFR 320.4. To clarify what documentation is appropriate in certain areas of the public interest review and balancing process, the Corps developed Regulatory Guidance Letter (RGL) 84-09. This RGL clarifies documentation required for public interest review including cumulative impacts, practicable alternatives, water dependency and important

wetlands. RGL 84-09 is included as enclosure 1. The Corps acknowledges the expiration date of the RGL; however, unless superseded by specific provisions of subsequently issued regulations or RGL's, the guidance provided in the RGL generally remains valid after the expiration date.

Please provide a detailed and extensive discussion of the following items:

a. Provide the revised functional assessments and figures discussed in the April 18, 2016 meeting.

b. To the extent practicable, please address the enclosed comments received in response to the public notice.

c. Provide whatever specific scientific and factual information you may believe is relevant to clearly demonstrate that the project meets the 404(b)(1) guidelines (40 CFR 230.10(a)) and how your preferred alternative is the least environmentally damaging practicable alternative when compared to the CSX alternative identified by Indian River and Martin Counties. The 404(b)(1) guidelines state, "An alternative is practicable if it is available and capable of being done after taking into consideration cost, existing technology and logistics in light of overall project purpose."

d. After considering RGL 84-09, provide whatever specific scientific and factual information you may believe is relevant to supplement your Evaluation of Public Interest letter dated March 31, 2015 included in the AAF FEIS.

Any other information you feel may be helpful to fully justify the proposed action should also be submitted at this time. Your application will be held in abeyance for 30 days pending receipt of your response. If we do not hear from you within the 30 days, we will initiate final action without your response. Final action may be issuance, denial or deactivation of your Department of the Army permit application.
