More Brevard Reopenings

Executive Order 20-123 has gone into effect, bringing all Florida counties into full Phase 1 Plan for Florida's Recovery. The order provides the following:

Restaurants and food establishments statewide may allow on-premises consumption of food and beverages so long as they adopt appropriate social distancing measures and limit their indoor occupancy to no more than 50 percent of seating capacity. Outdoor seating is permissible with a minimum of six feet between parties.

Retail sales establishments statewide may open if they operate at no more than 50 percent of their building occupancy and abide by the safety guidelines issued by the CDC and OSHA.

Museums and libraries statewide may open at 50 percent of their building occupancy.

Gyms and fitness centers statewide are permitted to reopen at 50 percent of their building occupancy with social distancing in place and sanitization after each use of equipment.

The Brevard County Board of County Commissioners, along with a policy group activated as

part of the COVID-19 pandemic response, have rescinded beachside parking restrictions. County-controlled beachside parks and beachside public parking access areas are open for most beaches. Removal of barricades put in place to block access to beachside parking areas has begun.

Municipalities are expected to announce openings of beachside parking access at a later date.

The Canaveral Port Authority opened Jetty Park at 50% for beach access parking only, no campground stays permitted. Additional information about Jetty Park.

Commissioners and policy group members took action in response to Gov. Ron DeSantis' Phase 1 Re-Open Florida plan. Among other actions taken, all county facilities will be open for public access. The county has installed new protective measures such as plexiglas sneeze guards in areas visited regularly by the public, and implemented enhanced facility cleaning and disinfectant protocols put in place during the COVID-19 response to include regular sanitizing of frequently touched surfaces, such as door

handles, stair railings and counter tops, in all county government facilities. Some offices will operate by appointment only.

Also, county libraries will begin opening in phases and in compliance with the Governor's 25 percent capacity recommendation and Centers for Disease Control recommendations for social distancing and sanitization.

Brevard County campgrounds Manatee Hammock, Titusville; Wickham Park, Melbourne; and Long Point, just north of Sebastian; are open at no more than 50% capacity. Every other campsite can be occupied.

Brevard Zoo reopened on May 23. Zoo visitor guidelines are in place. Visit <https://brevardzoo.org/support/opening-guidelines/> for information.

The seating limit is only 50% as I'm writing, so it might be worth your time to call before making a plan. If you have a large group, definitely call first.


Restaurants may not accept groups with more than 6 if they don't have large tables, and as I'm writing, gatherings are limited to 10 anyway.

Save our Indian River Lagoon Program Progress:

The Indian River Lagoon Coalition, with support from other environmental groups, brought forward the facts on what was killing the Lagoon and how we could pay for the recovery with a self-imposed tax. The County Commission was persuaded to put the referendum on the ballot in 2016 where it passed in every precinct in Brevard. We, as taxpayers, now have a responsibility to know how the county is handling our money. We have a Citizen's Oversight Committee (COC) that is composed of citizens, League of Cities, and environmental professors from colleges like FIT. The COC is responsible to study the projects and allotted funds for justification and what will give the most benefit. They are doing a good job, but I think as residents and tax payers, we should all be interested in what is being spent, what has been completed and what is to be completed over the next 10 years.

As I was reading "draft-2020-save-our-indian-river-lagoon-project-plan-update.docx" on the Brevard County website, I was surprised to read: "It is important note that there are no regulations on the concentration of nutrients in reclaimed water that is used for irrigation." UCF stated some is good, but what some of our cities are putting out is terrible and likely leaching back into the Indian River Lagoon. They stated, "Nitrogen leaching increases significantly when irrigation is greater than 2 centimeters per week (0.75 inches per week), even if the nitrogen concentrations are half of the maximum Institute of Food and Agricultural Sciences recommendation

of 9 milligrams per liter." According to the report, the worse culprits are the ones being invested:

City of Palm Bay Water Reclamation Facility, permitted up to 4.0 million gallons a day, currently putting out 1.20 million gallons per day, and a nitrogen concentration of 29.4 mg/liter, way above the maximum IFAS recommendation.

City of Melbourne Grant Street WWTF, permitted up to 5.5 million gallons per day, currently using 2.08 million gallons per day, and had nitrogen concentration of 21.0 mg/liter.

City of Titusville Osprey WWTF, permitted up to 2.75 million gallons per day, currently using 1.67 million gallons per day, and has a nitrogen concentration of 12.7 mg/liter.

At least this year Brevard County is addressing this excess nitrogen in the cities reclaimed water. Fixing Palm Bay, Melbourne and Titusville's reclaimed water will remove 72,033 pounds of nitrogen from the Indian River Lagoon per year, and 13,760 pounds of phosphorus.

Feral Cats and Scrub Jays & Other Threatened and Endangered Species

The following article and presentation may seem boring, but it relates to a lot of problems that residents of Port St. John have expressed

concern about. I will begin with mine. Port St. John has - or had - a polygon of Scrub Jays, which are a threatened and Endangered Species. We also have feral cats that are prominent. I am concerned about all life and was annoyed to the point of biting nails in half when the Sheriff and county went along with Cat Colonies and allowed them to roam free. Cats are not wild animals. They have been domesticated for thousands of years, plus they are a great comfort to many people. Cats and dogs are members of our households and our friends. We no longer see any birds in our back garden where there used to be. Now either feral or our neighbor's cats are allowed to roam daily through my garden.

Last year a property on Fay Blvd. came up at the Port St. John Planning & Zoning Advisory Board. I said there are Scrub Jays on that lot. The developer said the feral cats ate them. This is on the record. I also asked if Fish & Wildlife had been contacted. I was told they were and were told there were no Scrub Jays on the property. I'm assuming due to the feral cats.

This is unacceptable and could be illegal. Cruelty to animals is illegal. At times I have read stories on Facebook from folks who live

next door to people who mistreat their animals. In the state statutes shown below, are the laws pertaining to both our pets and wildlife? If you see infractions, please call Fish and Wildlife.

The following is from the Florida Department of Environmental Protection website exactly as written:

Florida Scrub-Jay is One of a Kind:

The Florida Scrub-Jay is a loyal and social Florida native.

It's the state's only endemic bird, which means the Florida Scrub-Jay is found nowhere else, and its need for a specific habitat is one reason why Scrub-Jay numbers are declining. The only bird species that requires a sandy, scrubby habitat to survive is the Florida Scrub-Jay.

As the state's human population has grown, development has increased and the Scrub-Jays' choice habitat has become more limited. A Scrub-Jay family's permanent territory averages about 22 to 24 acres, which makes it challenging for young birds to find suitable space for a family.

The species is federally listed as Threatened, in large part due to loss of habitat and decades of fire suppression that allowed scrub habitat to

become overgrown. Prescribed burning helps maintain the bare ground and shrub height vital for Scrub-Jay survival. The current Florida Scrub-Jay population is estimated at about 7,700 to 9,300 birds. The sandy habitat necessary for Scrub-Jays is protected by a number of Florida state parks. Lake June-in-Winter Scrub State Park near Lake Placid is home to a number of rare animals and plants, including the Florida Scrub-Jay. The largest amount of protected Scrub-Jay habitat in Southeast Florida can be found at Jonathan Dickinson State Park. In Central Florida, you might spot a Florida Scrub-Jay while hiking the trails at Allen David Broussard Catfish Creek Preserve State Park.

Scrub-Jays also make their home in the scrubby flatwoods of Oscar Scherer State Park.

Help the Florida Scrub-Jay

- Provide habitat for Scrub-Jays by planting and protecting scrub patches on your property. Maintain a maximum height of 10 feet for vegetation if you live on or near a Scrub-Jay habitat.
- Protect Scrub-Jays from family pets, especially cats. Encourage passage and strict enforcement of community leash laws for dogs and cats.
- Restrict use of pesticides. They can limit or contaminate the insects consumed by jays.
- Support establishment of Scrub-Jay preserves. Managed habitat is essential for protecting the species.
- Do not hand-feed them; it is illegal and a danger to their well-being.

The following is a Report to U.S. Fish & Wildlife Service in December 2002, from the University of Florida Conservation Clinic, by Pamela Jo Hatley, J.D. Candidate, 2003 under Thomas Ankersen, Director. It talked of implications on protection of Feral Cats and how it

affects endangered species like six subspecies of beach mice, Key Largo woodrat, Key Largo cotton mouse, Lower Keys marsh rabbit and the Florida Scrub-Jay. The legal considerations are with the Federal Endangered Species Act, the Migratory Bird Treaty Act and various state statutes. There may be local ordinances but they vary a lot back and forth on local implications. Federal and state statutes will take precedence. Since this is pulled from the slides from wording from Congressional Acts and Florida Statues, most of the wording is straight from slides.

Endangered Species Act, 16 USC §1538, Prohibited Acts. (a)(1) ...with respect to any endangered species of fish or wildlife listed pursuant to section 4 of this Act, it is unlawful for any person...to *(B) take any such species...

(G) violate any regulation pertaining to such species or to any threatened species...promulgated by the Secretary pursuant to authority provided by this Act.

16 USC §1532, Definitions

For the purposes of this Act-- **** (19) The term "take" means to harass, harm, pursue, hunt, shoot, wound, kill, trap, capture or collect, or to attempt to engage in any such conduct.

50 C.F.R. §17.3 Definitions

Harass in the definition of "take" in the Act means an intentional or negligent act or omission which creates the likelihood of injury to wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering...

50 CFR §17.3 Definitions

Harm in the definition of "take" in the Act means an act which actually kills or injures wildlife. Such act may include significant habitat modification or degradation where it actually

kills or injures wildlife by significantly impairing essential behavioral patterns, including breeding, feeding or sheltering.

Florida Constitution, Article IV, §9 Florida Fish and Wildlife Conservation Commission –Management, protection, and conservation of wild animal life...

§372.072, F.S. Endangered and Threatened Species Act:

(3)(b) "Endangered species" means any species of fish and wildlife, naturally occurring in Florida, whose prospects of survival are in jeopardy due to modification or loss of habitat; ...disease; predation ...or other natural or man-made factors affecting its continued existence. (c) "Threatened species" means any species ... which may not be in immediate danger of extinction, but which exists in such small populations as to

become endangered if it is subjected to increased stress as a result of further modification of its environment.

§372.0725, F.S. Killing or wounding of any species designated as endangered, threatened or of special concern; criminal penalties - It is unlawful for a person to intentionally kill or wound any fish or wildlife of a species designated by the Fish and Wildlife Conservation Commission as endangered, threatened, or of special concern... Any person who violates this provision with regard to an endangered or threatened species is guilty of a felony of the third degree...

Rule 68A-27.0011, F.A.C. Killing Endangered Species

No person shall kill, attempt to kill or wound any endangered species as designated in Rule 68A-27.003.

Rule 68A-4.005, F.A.C. Introduction of Foreign Wildlife or Freshwater Fish or Carriers of Disease

(1) It shall be unlawful for any person to ...release or introduce in the state any wildlife ... that is not native to the state unless such person shall first secure a permit from the Commission.***

(3) No person shall release or introduce in the state any wildlife, ... or any other organism that might reasonably be expected to transmit any disease to wildlife ...

§828.12, F.S. Cruelty to animals

(1) A person who... deprives of necessary sustenance or shelter, ... any animal, or causes the same to be done... is guilty of a misdemeanor of the first degree...

(2) A person who intentionally commits an act

to any animal which results in the cruel death, or excessive or repeated infliction of unnecessary pain or suffering or causes the same to be done, is guilty of a felony of the third degree...

§828.13, F.S. Confinement of animals without sufficient food, water, or exercise; abandonment of animals

(1) "As used in this section: "Abandon" means to forsake an animal entirely or to neglect or refuse to provide or perform the legal obligations for care and support of an animal by its owner."

(2) "Owner" includes any owner, custodian, or other person in charge of an animal.

(3) "Any person who is the owner or possessor, or has charge or custody, of any animal who abandons such animal to suffer injury or malnutrition or abandons any animal in a street, road, or public place without providing for the care, sustenance, protection, and shelter of such animal is guilty of a misdemeanor of the first degree, punishable as provided..."

§403.412, F.S. Environmental Protection Act

(2)(a) The Department of Legal Affairs, any political subdivision or municipality of the state, or a citizen of the state may maintain an action for injunctive relief against:

1. Any governmental agency or authority charged by law with the duty of enforcing laws, rules, and regulations for the protection of the air, water, and other natural resources of the state to compel such governmental authority to enforce such laws, rules, and regulations;

2. Any person, natural or corporate, or governmental agency or authority to enjoin such persons, agencies, or authorities from violating any laws, rules, or regulations for the protection of the air, water, and other natural resources of the state.


Scholarship committee chair Barbara Terhune led the committee through the process of evaluating applicants in the areas of academic

Monthly Tax Update

Here are several COVID-19 impact changes.

Existing Installment Agreements are delayed between April 1, 2020, and July 15, 2020. You will have to stop payment during this period without penalty. However, you will probably have to pay a stop payment fee to the financial institution. The scheduled payments are not suspended automatically.

All Field Collection Activities are suspended and all field revenue officers are prevented from enforcement actions, such as liens and levies. In addition, there will not be any new collection activities until after July 15, 2020.

Required Minimum Distributions are not required for the 2020 tax year. This is for taxpayers who are over 70½ with pretax retirement accounts or any taxpayers who have an inherited retirement account. Additionally, the required minimum distribution starting age is now 72. Therefore, if you turn 70½ after December 31, 2019, you will forego the required minimum distribution requirement until the year you turn 72.

Individual and Married Filing Joint Tax Returns are not due until July 15, 2020. No extension was required and you will not incur any penalty or interest on any tax liability due if paid by July 15, 2020. You will be required to file an extension if you are unable to file your return by July 15, 2020, and the extension will permit you to file the return by October 15, 2020. Remember, an extension does not extend your payment requirement by July 15, 2020. Any tax not paid on or before July 15, 2020, will incur the late payment penalty and interest until paid.

Business Entity Tax Returns were required to file an extension if their due date was March 15, 2020. The entity will incur a late filing penalty if an extension was not filed. You may avoid this late filing penalty by submitting a statement based on reasonable cause or requesting the First-Time Penalty Abatement Waiver, if applicable. The business entities include partnerships and S-corporations, not C-corporations.

FinCen FBAR Form 114 had a filing date due on April 15, 2020. However, an automatic extension until October 15, 2020 is in effect and your only requirement is to file by October 15, 2020.

Department of Florida Division Uniform Annual Report for corporations and limited liability

companies was due by May 1, 2020. The Division has moved the filing deadline to June 30, 2020, without incurring the late \$400 filing fee.

Stimulus Payments used to pay your spouse's past debt liabilities can be redirected by filing the Form 8379, Injured Spouse Allocation, with the Internal Revenue Service Center by signing and mailing in the form.

However, IRS is not processing any signed and mailed returns or correspondence. This includes Form 8379, late returns, responses to correspondence received from the Service Center, Power of Attorney's or any effort to resolve any tax circumstances until the employee return to work decision is made. This also includes telephone inquiries and it doesn't matter whether you're a taxpayer, Enrolled Agent, CPA or Attorney.

Hopefully, you have survived this situation and we all pray we return to some type of normalcy soon. Bless you all!!!

Should I travel within the US?



CDC does not generally issue advisories or restrictions for travel within the United States. This may include settings such as conferences, public events, religious gatherings, public spaces and public transportation.

Are you or your travel companion(s) more likely to get severe illness if you get COVID-19? People at higher risk for severe disease are older adults and people of any age with serious chronic medical conditions (such as heart disease, lung disease, or diabetes). CDC recommends that travelers at higher risk for COVID-19 complications avoid nonessential air travel.

Do you have a plan for taking time off from work or school, in case you are told to stay home for 14 days for self-monitoring or if you get sick with COVID-19? You may be asked to stay home


to self-monitor and avoid contact with others for up to 14 days after travel.

Do you live with someone who is older or has a serious, chronic medical condition? If you get sick with COVID-19 upon your return from travel, they may be at risk of infection.

Is COVID-19 spreading where I live when I return from travel? Consider the risk of passing COVID-19 to others during travel.

Depending on your unique circumstances, you may choose to delay or cancel your plans. If you do decide to travel, be sure to take steps to help prevent getting and spreading COVID-19 and other respiratory diseases during travel.

It is unknown as to where the mysterious sounds of booms that have been reported are coming from. They have nothing to do with the construc-

tion of the high speed train. It also seems that the areas they are coming from change.

The Sheriff's Office has reported scams going around in relation to Covid-19 and the stimulus checks, looking for your information. The IRS NEVER calls you for your information. If you receive mail, please verify the telephone number and call the local IRS office, NOT the phone number on the paperwork.

The Sheriff's Office has increased patrols and traffic enforcement in this area. There is also a Deputy looking into how to close off the north end of Pine St. leading out to the Black Hole.
