

Good Day! by Maureen Rupe **Cement Recycling Facility**

The City of Titusville is about to ruin the main entrance to Space Coast Regional (formerly

TICO) Airport and cause harm to the Indian River Lagoon and leave residential areas open to health hazards. A concrete recycling facility is planned for 84 Golden Knights Blvd. (see map adjacent).

According to an article written by MacKenzie DiLeo on May 12, 2021, titled, "Porters Community Residents Are Growing Tired Of Noise And Dust Coming From Neighboring Cement Companies," "Any and all dust that is tracked off site from their facilities is a violation of their permits." The article discussed issues at a Concrete Recycling Facility close to

I don't understand how a recycling plant stays within the requirements of their permits as the same article stated the following: "Tim Renfroe, the owner of Florida Concrete Recycling, said the company does its best to control dust. They try to minimize dust through sweeping and cleaning the surrounding roads when necessary. Still, he

explained that dust coming from the site is not and specifically its interruption of her and her completely avoidable."

"You can't do what we do and have it 100% dust free," Renfroe said.



Did I mention the noise? The above article stated from an adjacent resident: "Fillie says the noise sounds like a machine gun going off, it's crazy." He can handle the loud music and other noise that comes with living near downtown, but would expect in an urban environment.

He's not alone in his concerns. Janie Williams, a lifelong resident of the historically black

neighbors' sleep. Williams has, in the past, tried bringing her concerns to the Gainesville City Commission, but to little avail. "The trucks start

> running about 1, 1:45, 2:45 in the morning when you are in your deep sleep, and that's not good for the neighborhood," Williams said. "Sometimes I can go back to sleep, and sometimes I can't."

> A 2018 study in the National Center for Biotechnology Information explored the health effects of environmental pollution for nearby communities. It found dust pollution resulting from activity in industrial complexes could be detrimental to human

health. The pollution coming from the site could "...enter the human body through the respiratory system or skin, and can cause allergic reactions, respiratory symptoms and various acute and chronic diseases, such as asthma, chronic obstructhe noise from the industrial plant is more than he tive pulmonary diseases, lung dysfunctions, skin and eye diseases, acute bronchitis, cardiovascular disease and cancer."

to a number of residential properties on the east and west side of U.S.1. According to an article titled "Danger in the Air" dated September 25, 2014, no author mentioned, "Mining, processing and transporting sand generates large quantities of silica dust, which is notorious for the damage it does to the lungs and respiratory system when inhaled...." "Silica can impede breathing and cause respiratory irritation, cough, airway obstruction and poor lung function (Rego 2008). Chronic or long-term exposure can lead to lung inflammation, bronchitis and emphysema and produce a severe lung disease known as silicosis, a form of pulmonary fibrosis (Hnizdo 2003)."

Silica-related lung disease is incurable and can be fatal, killing hundreds of workers in the U.S. each year. The National Institute for Occupational

Safety and Health (NIOSH) has estimated that at least 2.2 million workers in the mining and construction industries are exposed to inhalable silica each year. However, the Institute noted, "There is no surveillance data in the U.S. that permits us to estimate accurately the number of individuals with silicosis. The true extent of the problem is probably greater than indicated by available data. up a lot of dust affecting residents at least a mile (Weissman and Schulte 2011)...."

I would assume that something of this magnitude shouldn't be located close to residential areas as the same EWG article states, "Children, older adults and people with respiratory diseases are especially at risk. Unfortunately, the article also states, "There is no federal standard for ambient air exposure to silica outside the workplace. Based on occupational data, the EPA came up with a

health-protective benchmark for crystalline silica in PM10 particles of 3 micrograms per cubic meter (µg/m3) (Gift 1997; US EPA 1996). Crucially, however, EPA's benchmark did not consider the risks of exposure to vulnerable populations such as children or people with respiratory disease."

The way the wind blows around here will stir from this location.

I'm told by an engineer that cement dust (lime and silica) is very corrosive to jet engines. The airport and aircraft owners will not want constant cement dust coming from any east winds blowing into the intakes of all those airplanes. The dust is also corrosive to aluminum - the main metal in all airplanes. This plant could potentially contribute to aircraft failures. cont., next page

plant? If they plan to use that water to spray to lower the amount of dust, the water is at risk of becoming a cesspool of runoff chemicals that will eventually make it to the IRL. This is probably the worst location to locate a cement recycling plant.


would be up to 50 trucks a day, and as it is next to the railroad track, the applicant said being near the railroad tracks was a plus because they will be bringing in concrete trash from distances. This will be a slap to both the city's residents and the residents of the entire county that have put in place the self-imposed tax to clean up the Indian River Lagoon. Why should we be paying to clean up the Lagoon when we have cities within our county that are destroying any progress we make? Decisions affecting the Indian River Lagoon should not be left up to the city.

I've also heard from an individual that has worked at a concrete recycling facility in the past that any building that processed chemicals are always sent to these facilities as opposed to sending the concrete to a dump or burying it on a lot.

This concrete recycling facility, due to its location, will affect us in multiple ways: Entrance to TICO Airport, the Indian River Lagoon, Tom Statham Park with the District 1 County Commissioner's office, and a number of residents living north and south of the facility on U.S.1 and River Edge Drive. This is getting us into the stupid factor as there are no state, county or city requirements to test for what we are putting into the Lagoon after we have supposedly removed various point sources of pollutants.

Michael Myjak and Maureen Rupe representing the Indian River Lagoon Roundtable are requesting the Charter Review Commission to pass a proposed amendment for the "Right to Clean Water." I believe we will have a clear majority of Brevard voters who will pass this amendment. But unfortunately, many in the development, business and government only think of what it will cost, not how it will benefit us. If someone sues, it's not a monetary payout. The county commission would have to show the county priorities and a judge would determine what other priorities the county might have to put off moving us close to having "Clean and Healthy Water."

Brevard County Charter Amendment-Right to Clean Water:

Brevard County residents and organizations respectfully request members of the Charter Review Commission (CRC) to consider amending the charter to ensure present and future generations are able to protect themselves and their interests from harm. The "Right to Clean Water" proposal creates a local cause of action for equitable (declaratory or injunctive) relief, which may include a "polluter pays" form of restorative relief. As the proposal's ultimate design will depend on the will of the CRC members and public comments, Attachment 1 is provided as a skeletal framework.

Attachment 2 provides the legal basis and argument that the County has the authority to enact this measure and that state preemption found in FL Stat. 403.412 (9)(a) does not apply.

This proposal starts off with the premise: Brevard County has the power and duty to protect itself and its residents, businesses, visitors and economy from legalized harm.

Legalized harm is caused by the action or inaction of federal and state governments, be it erratic definitions of health, harm, public interest, various scientific standards or environmental impact considerations or requirements; poor staffing, budgeting or resourcing decisions; substandard design or enforcement of basin action management plans or nutrient load limits; continued permitting of substandard or inappropriately located onsite septic systems; inappropriate use of fertilizers, herbicides; etc.

Waters such as the Indian River Lagoon have suffered from and continue to be impacted by substandard, but legal, government harm. Missing from the current system is the ability to effectively challenge such continued or planned harm. We believe it is the people's inherent right to question and stop such practices to better protect themselves, their families, their businesses and their communities.

The problem isn't a lack of strong environmental laws in Florida, nor is it due to a string of illegal pollution. The problem *set* is systemic and more like

death by 1,000 paper cuts, which is comprehensively difficult and expensive to remedy for large water bodies such as the Indian River Lagoon, much less to fully restore. To make sense of our hundreds-of-millions of taxpayer dollar investment, we must be able to establish a stopgap – a "do no (more) harm" mandate, and allow individuals, businesses and non-profits to engage in the litigation to arrive at a better system. Courts will rule in equity, considering what's possible, what harm is preventable, and declare certain actions or policies of inaction to be in violation of the Right to Clean Water. Courts may award declaratory or injunctive relief, to either prevent harm or, if sufficient evidence is presented, to restore waters to their condition just before the harm occurred. Outside of attorney's fees and court costs, (which can be awarded to prevailing plaintiffs), any money that changes hands will be applied (earmarked) directly to the restoration of waters. Courts have the power to ensure government agencies do what the law says they should do.

A no-cost, non-governmental solution to restore ecological balance for all to enjoy is a win-win opportunity. The only opponents to such a measure will be those who benefit and wish to continue to benefit from exacting harm on Brevard's shared natural resources under the current system, and their banner will likely point to some property rights fear. This proposal only strikes at legalized "rights" to pollute or otherwise irresponsibly degrade waters, infringing on the rights and substantial interests of everyone else. This proposal provides Brevard County a way to pivot back to good while balancing all competing interests through courts of equity, justice and fairness.

may bring those living, working and playing in Brevard County. It presents a chance for our leaders to show all other communities and states that it's possible to have a thriving economy AND a thriving ecology, balanced for present and future generations, due to a small systemic tweak to establish and ensure a Right to Clean Water.

The Amendment has to be discussed three times before the Charter Review Commission decides to pass it on for the November ballot. The County Commission has to do a review, but the Charter states they can't turn down amendments provided by the Charter Review Commission.

We need support from everyone who agrees we have the right to Clean Water. Like I said earlier, there are people who say it is too expensive to have clean water. (What!?) In the 2015-2016 Charter Review, I proposed a similar amendment. The proposal was for Unpolluted Air and Clean Water, and out of the other 15 attendees, I couldn't even get one other person to agree with the proposed amendment.

The last meeting will be the middle of May

Monthly Tax Update

Every taxpayer needs to be aware on ways to pay if you find you owe taxes or need to make estimated tax payments. Therefore, it may be of interest to know the Internal Revenue Service (IRS) offers several payment options. Here are some key points to keep in mind.

- Never send cash! Electronic payment options are the quickest and easiest way to pay your tax. Check out IRS Direct Pay or EFTPS to pay directly from your bank account at www.irs.gov. It's secure and free. You'll get instant confirmation your payment has been submitted. You can pay taxes electronically 24/7. Just click on the payments tab near the top left on the home page.

- If you filed an extension, you may be able to pay through your tax software when you file the return.

- Another method is to choose the option to pay with a credit or debit card. This is also accomplished by going to the irs.gov website and be advised that the company processing your payment will charge a processing fee.

- You may enroll in the Electronic Federal Tax Payment System (EFTPS). The EFTPS method permits you to pay your federal taxes electronically and remembers all of your pertinent information. You have a choice to pay using the Internet, or by phone using the EFTPS Voice Response System.

- If you can't pay electronically, you can still pay by a personal check, cashier's check or money order. Make it payable to "United States Treasury." Be sure your name, address and daytime phone number appears on the front of your payment. Also, write the tax year, Form 1040, and your Social Security number in the memo section of the check and you'll use the social security number shown first if it's a joint return payment. You will also send a completed Form 1040-V payment voucher in the envelope with your payment or mail it with your tax return to the IRS. Make sure you send them to the correct address listed in the instructions for the Form 1040-V. This will help the IRS process your payment and post it to your account correctly. You can get the form on IRS.gov/forms at any time.

If you can't pay your tax in full, the IRS urges you to still file your tax return on time. You should pay as much as you can with your tax return. This will help keep your penalty and interest costs down.

If the amount you owe is more than you can pay in full, then establish an installment agreement which will allow you to pay the balance over time. There will be a processing fee charged by the IRS when you establish this arrangement. There is an Online Payment Agreement tool on IRS.gov that makes it a real easy way to apply if the amount due is under \$50,000.

Finally, if the amount is more than you can handle and you know there isn't any way that you'll ever pay it off, you may feel enticed to call one of the scammer advertising entities that will charge you unbelievable fees and never settle the debt. I would advise you to determine if an Offer in Compromise is possible first. You can go to the website "http://irs.treasury.gov/oic_pre_qualifier/" to determine if an Offer In Compromise is possible. If you find you fall within the parameters, I recommend you seek the assistance of a local Enrolled Agent, Certified Public Accountant or an attorney to prepare the documentation and settle the debt. Steer away from the "We can reduce your tax liability" nationwide advertising solicitors due to excessive billing techniques.


Mornings have gone from enjoying a quiet cup of hot coffee watching the birds at the feeder to sipping cool brew while trying to remember who will be




New COVID Vaccines Update

On Tuesday, Moderna released clinical data demonstrating that a new version of its Covid-19 vaccine that targets several mutations produced a stronger immune response against the major virus variants, including omicron and delta, than the company's current shots. Moderna's redesigned vaccine includes nine mutations found in the beta Covid variant.

The current vaccines were developed to recognize the spike protein which the virus uses to invade human cells. But the more the spike protein has evolved, the less likely the antibodies produced by the vaccine are able to recognize the virus and fight it, which reduces the efficacy of the shots. A 50-microgram dose of Moderna's new vaccine doubled the antibodies, which block the virus from infecting human cells, against the omicron variant six months after injection compared with the original booster at the same dosage, the data indicated. The updated shot also increased antibody levels against the delta variant six months after injection.

Moderna and Pfizer are developing new shots that target multiple virus variants in the hope of producing vaccines that provide longer-lasting protection against infection.

The FDA is debating whether the U.S. will need updated Covid shots ahead of an expected wave of infection in the fall.

Property Insurance Special Session

Governor Ron DeSantis has said he will call a May special legislative session to address problems in the property insurance system that have led to homeowners losing coverage and getting hit with large rate increases. DeSantis made the announcement during an appearance in Jacksonville but did not immediately specify the dates for the session. DeSantis indicated the insurance session would try to "...bring some sanity and stabilize and have a functioning market." DeSantis also said, "I am not confident we'd be able to punch it through this week. But what a special session in May. We're going to work with the legislathe reform of the property-insurance market."

DeSantis said the special session could address other issues Among the issues that did not pass were a plan to put additional requirements on condominium buildings after the deadly collapse last year of the Champlain Towers building in Surfside.

The House and Senate were at odds during the regular session about how to address the property-insurance problems. The Senate proposed allowing new deductibles of up to 2% on roof-damage claims – an outgrowth of complaints by insurers that questionable, if not fraudulent, roof claims are driving up costs, but the House rejected the idea.

Titusville Playhouse wants its patrons, supporters and community stakeholders in on the next Act. The award-winning operator of the historic Emma Parrish Theatre and newly opened Shuler Stage announced today that it has begun a master planning process to support an expansion of Titusville Playhouse, Inc. (TPI) arts facilities, operations and programming in downtown Titusville.

The public outreach and community engagement will begin immediately with public workshops and an online survey instrument being sent out to TPI's patrons and community groups. To lead this effort and assist TPI with other business and feasibility assessments, TPI has selected Theatre Projects after conducting a national search and concept development competition.

Founded in 1957, Theatre Projects is an internationally recognized group of planners, designers and innovators who have worked on more than 1,500 projects in 80 countries, including the Dr. Phillips Center for the Performing Arts (Orlando), New World Center (Miami), and the Woodruff Arts Center's Alliance Theatre Coca-Cola Stage (Atlanta), to name a few.

TPI envisions creating a community gathering space and cultural arts hub that is approachable, welcoming, and enriching to Titusville and surrounding communities. As a destination, it should support diverse, engaging, and quality experiences.

A centerpiece to the development plan is a new state-of-the-art multi-use venue programmed to include a 500-seat main stage theatre and an adjoining "black box" venue that can also host special events. The historic Emma Parrish Theatre (274 seats)—acclaimed for its unique, intimate house accommodations—will be retained to allow concurrent show offerings in addition to the newly added Shuler Stage. Other community gathering and event spaces may also be developed.

"We are very enthusiastic about working in partnership with Theatre Projects and the City of Titusville," said Executive Artistic Director Steven Heron. "It is our vision to have a variety of entertainment that will reach all facets of our community here in Central Florida."

"We look forward to hearing from our home community and all other markets that we serve,

as well as our many stakeholders," said TPI Board President Katy Ball. "As we develop a master plan for this performing arts hub as a destination in our downtown, we want to ensure we have captured the dreams of all who would like to help us vision it. Having our community's support will be essential to building a cultural asset that will positively impact our city for generations to come."

Protect Yourself From Scams, Fraud And Impostors

Scammers are aggressively targeting utility company customers across Florida and the rest of the country using sophisticated tactics to pocket quick cash. Here's a look at local scams happening now:

The caller pretends to be a Florida Power & Light Company (FPL) employee and insists your account is delinquent. Caller ID may even falsely display our number and appear to be FPL. The caller threatens to turn off power to your home or business within an hour if payment isn't made immediately, and may even claim a truck is on the way. The caller demands immediate payment only with a prepaid card or wire transfer and provides a call back number that mimics our customer service line. It's a scam. Don't pay.

FPL WILL NEVER:

- Demand immediate payment with a prepaid card or wire transfer through services such as MoneyPak, Zelle or Venmo to avoid service disconnection.
- Ask for personal information, such as account numbers or your Social Security number, unless you call us in which case we will ask questions to confirm you are the account holder.
- Knock on your door to sell a product or service. Always ask to see the FPL employee or contractor's photo identification badge and work request number prior to letting them in for scheduled appointments.

If this happens to you, take action:

Suspicious caller – Hang up.

Suspicious text or email – Delete it.

A visitor without official FPL identification – Shut the door and call the Sheriff's office to report the time and location. Call the BCSO North Precinct at 321-264-5100, not 911.

Sitting at this machine with the door open enjoying our small piece of paradise, my heart goes out to all who are going through such hardship and terror that is upon so many places at this time. Please know that many of us are offering up prayers for all of those who need it, whether start the day! illness or hatefulness is plaguing you.

I honestly don't know why I never knew of this wonderful park until now. It is exactly the kind of place I love visiting with or without young people. Every inch of its ninety-two acres offers something for most everyone, whether it be hitting, kicking or chasing a ball, hiking, jogging, or biking the three miles of pathways, flying a kite or enjoying a fresh grilled hot dog.

The day my daughter and I found this jewel was a perfect post card day. The sky was azure blue, slight chill to the gentle breeze and every once in a while, I caught a tiny whiff of something floral.

Prior to walking the paths, we took a slow drive around the perimeter and were very impressed with the expansive game fields. The parks website lists two multi-use fields, eight soccer fields, two of which are lighted, two lighted youth softball fields and five lighted adult softball fields. I have to admit I can't tell a youth softball field from an adult softball field or a multi-use field from a soccer field, lighted or not, but there were laughing kids and cheering adults on most of them. And that is what's important. Several of the fields have their own concession stands and all are very well maintained.

There are pavilions at each field complete with BBQ grills. The large ones will accommodate one hundred people and all are available for rent. There are ample restrooms. All are very clean,

bug and spider free.

I saw three large playgrounds for the youngest visitors, again well maintained and almost new looking. And there was lots of stuff to climb, swing on and slide down, not to mention space to just plain run around.

Anyone who knows me will not be surprised that after wandering the forested and marshy areas of the walking trails, I chose to take the wrong turn on the path that leads to and from the observation tower. We walked approximately two miles in the wrong direction before a kind fellow traveler pointed out that the tower was more than a mile behind us.

The trails are paved and also very well maintained. They meander through shaded areas and in full sun around the lakes. Families and singles on bikes and on foot passed us with a smile and a hearty "Good Morning." What a great way to

The bridges span smaller areas, affording glimpses of small bass and catfish. We were there toward the middle of the day so I wasn't expecting to see much wildlife. I looked for turtles or alligators to be sunning themselves, but didn't catch sight of any, save for one lone Aflac duck dozing among the hyacinths. I did see some kind of tracks in the soft soil between the pathway and the trees that were probably raccoon or armadillo.

The fifty-foot-tall observation tower sits in a beautiful old Florida marshy area. The wooden construction seems to blend in perfectly. I have to admit by the time we finally arrived at the tower my hips were warning me that attempting to climb five flights of stairs would certainly remind me I am no longer in the Spring Chicken category. I will conquer the tower on my next visit!

This park is well worth the thirty-minute drive north on U.S. 1. It's a great place to enjoy the great outdoors for a couple of hours or a day. I recommend insect repellent and sun screen and as always, please take only pictures and leave only footprints.
